AUSTRIAN TOURISTS AND SEVERAL EGYPTIANS ON 27 DECEMBER, INJURING SEVEN AUSTRIANS AND EIGHT EGYPTIANS. THE INCIDENT OCCURRED AS THE BUS HEADED THROUGH THE OLD CAIRO DISTRICT TOWARDS THE COPTIC MUSEUM. THE ATTACK BEGAN WHEN AT LEAST ONE TEENAGE BOY THREW STONES AT THE BUS, SHATTERING THE WINDSHIELD, FOLLOWED AUTOMATIC WEAPONS FIRE AND POSSIBLY A BLAST FROM AN EXPLOSIVE DEVICE. NO CLAIMS HAVE BEEN MADE FOR THE INCIDENT.
