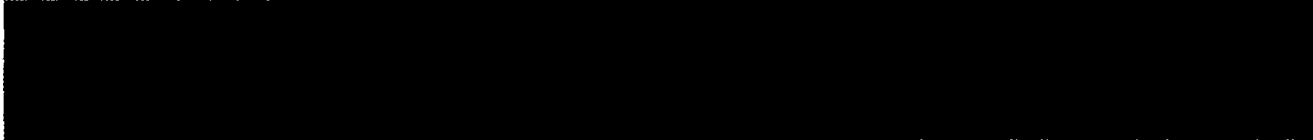

SUMMARY: ~~SECRET~~ PRC-IRAN TANK COOPERATION PROJECT IS PROCEEDING. IRANIANS RAISE 125MM TANK AMMUNITION AS A POTENTIAL PROBLEM AREA FOR THE PROGRAM. IRANIANS ARE REPORTEDLY SATISFIED WITH THE ISRAELI DERIVED FIRE CONTROL SYSTEM, AND ARE AWARE OF THE SOURCE OF TECHNOLOGY TEXT: 1. ~~SECRET~~ (b)(1), 1.4 (c) THAT THE 125MM SMOOTH BORE GUN TO BE INCLUDED IN THE NEW IRANIAN TANK IS CAUSING SOME PROBLEMS FOR NORINCO. THE PROBLEM REGARDS SOURCE OF AMMUNITION. APPARENTLY THE IRANIANS

THEIR TANK AMMUNITION, AND HAVE RAISED THE AMMUNITION

CONTROL SYSTEM, PROVIDED BY SHAUL ((EISENBERG)) SEVERAL
YEARS AGO, WORKS "QUITE WELL, BOTH FROM STABLE FIRING
POSITIONS AND ON THE MOVE." (b)(1),1.4 (c) WAS UNABLE TO
QUANTIFY "QUITE WELL," BUT NOTED THAT THE IRANIANS
WERE SATISFIED WITH THE SYSTEMS FIRE ON THE MOVE
PERFORMANCE.
