SUMMARY: (S/NF/NC) HASHEMI OF TAGELL UK, LTD WILL BE IN BEIJING WITH THE IRANIAN AIR FORCE DIRECTOR OF PROCUREMENT ON 29 OCT. SUBJECT OF DISCUSSION WILL BE THE PURCHASE OF THE HQ2J, 601 AND 801 ANTISHIP MISSILES AS WELL AS THE F7.

1. (S/NF/NC) (b)(1).1.4 (c) IS QUITE FAMILIAR WITH THE ACTIVITIES OF ((HASHEMI)) OF TAGELL UK, LTD IS AWARE OF A PLANNED TRIP BY A GROUP OF FIVE TO SIX IRANIANS TO BEIJING ON 29 OCT. THE GROUP WILL BE HEADED BY THE IRANIAN AIR FORCE DIRECTOR OF PROCUREMENT AND IS BELIEVED TO BE INTERESTED IN THE PURCHASE OF A NUMBER OF CHINESE WEAPONS SYSTEMS WHICH INCLUDE THE HQ2J SURFACE TO AIR MISSILE SYSTEMS, THE 601 AND 801 ANTISHIP MISSILE AS WELL AS THE F7 AIRCRAFT. (b)(1).1.4 (c) THAT THE IRANIANS WOULD PREFER TO BUY THE F8 BUT THEIR APPROACHES ON THIS AIRCRAFT MODEL HAVE BEEN FIRMLY REBUFFED BY THE CHINESE.

2. (S/NF/NC) (b)(1).1.4 (c) THAT THE GROUP WILL BE STAYING IN THE BEIJING HOTEL AND SHOULD REMAIN IN THE CITY FOR FIVE TO SIX DAYS. (b)(1).1.4 (c) DID NOT STATE IF THE GROUP WOULD VISIT OTHER CITIES IN THE PRC. IN THE PAST, THESE TYPES OF GROUPS LED BY HASHEMI HAVE REMAINED ALMOST EXCLUSIVELY IN BEIJING. THE MEETINGS HAVE INCLUDED NOT ONLY CHINESE BUT NORTH KOREAN OFFICIALS.

3. (S/NF/NC) THIS VISIT BY HASHEMI WILL BE ASSISTED BY ((ZHENG)) LIMING, DIRECTOR OF THE HONG KONG BASED, LOFTECH, LTC. MS. ZHENG APPEARS TO HAVE USEFUL CONTACTS WITH XINSHIDAI AND CATIC. AS PREVIOUSLY REPORTED (b)(1),(b)(3):10 USC 424.1.4 (c) ZHENG IS THE LOCAL AGENT FOR CAAC INDUSTRIAL AVIATION SERVICE CORP AND CHINA UNITED AVIATION CORP.

4. (S/NF/NC) HASHEMI'S COMPANY, TAGELL UK, LTD WILL SOON OPEN A BRANCH OFFICE IN BEIJING. (b)(1).1.4 (c) TAGELL HAS BEEN NATIONALIZED BY THE IRANIAN GOVERNMENT. (b)(1).1.4 (c) DOES NOT KNOW WHO WILL MANAGE THE BEIJING OFFICE.
