SUBJECT: MIIRA: Procurement of Vital Materials in U.S. Political MATTERS - Cuba

1. Reference (a) alerted the Navy Department of a specific case wherein Cubans were managing to buy vital spare parts to operate U.S.-confiscated industries. Since the action of the Cuban Government in many cases is against the best interests of the U.S. this information will continue to be forwarded when available.

2. There is great risk by certain sources to make such information available. It is hoped that this type of report may get quick action.

5. A major supply outlet from the U.S. to Cuba is Parts Suppliers International. A Mr. Victor PUIG is in charge. Most of the equipment handled by Parts Suppliers is delivered through the WEST INDIA SHIPPING CO., located at 777 Biscayne Blvd, Miami.
