A SLIDE OF 2010 FIGURES SHOWS 28,585 MARIJUANA PLANTS CLEARED OVER 4,210 HECTARES FOR 364,155 KG AND 11,011 PLANTS IN 1,522 HECTARES OF POPPY FIELDS FOR 100KG OPIUM 137KG COCAINE, 65KG CRYSTAL, 2,437 FIREARMS, 150 GRENADES, 1074 VEHICLES, 141 DESTROYED RUNWAYS AND 1217 PERSONNEL DETAINED IN THE REGION.

- SLIDES 17-19 - CONCLUSION SLIDES HIGHLIGHT THE REGIONS STRATEGIC SIGNIFICANCE, SPECIFIES 'THE CONDUCT OF MILITARY SUPPORTED ACTIONS BY CIVILIAN AUTHORITIES' AND THE RETALIATORY NATURE OF VIOLENCE ON THE BORDER. THE SLIDE ALSO STATES INTENSIVE TRAINING ON HUMAN RIGHTS AND HUMANITARIAN LAW RESULTED IN A LOWER COMPLAINT RATE.
