~~(S)~~ PEACE TALKS BETWEEN THE RWANDAN GOVERNMENT AND REBEL REPRESENTATIVES ARE TO BEGIN ON 10 AUGUST IN ARUSHA, TANZANIA. A CEASE-FIRE BETWEEN THE TWO GROUPS WENT INTO EFFECT ON 31 JULY. THE RWANDAN DEFENSE MINISTER HAS CHARACTERIZED VIOLATIONS THAT HAVE OCCURRED SINCE THEN AS FORMS OF INTIMIDATION, BUT NOT OF ANY MILITARY SIGNIFICANCE. IMPLEMENTATION OF THE CEASE-FIRE WILL BE SUPERVISED BY A NEUTRAL MILITARY OBSERVER GROUP COMPRISED OF 50 PERSONNEL FROM SENEGAL, ZIMBABWE, NIGERIA, AND AN AS YET UNNAMED COUNTRY. ~~(DECL OADR)~~
