PART I: (U) WARNING FORECAST -- THIS FORECAST IS INTENDED TO ALERT SENIOR (b)(3):10 USC 424 OFFICIALS TO POTENTIAL DEVELOPMENTS THAT IMPACT ON WESTERN INTERESTS. COVERAGE IS FROM 9 THROUGH 16 FEBRUARY 1993.

ALTHOUGH THIS INCIDENT TOOK PLACE NEAR ZAGREB, CROATIA, THE AIRCRAFT WAS NEAR SERB-CONTROLLED TERRITORY WHEN ATTACKED. ~~(DECL OADR)~~

~~(S)~~ THE OUTBREAK OF VIOLENCE IN NORTHERN **RWANDA** BY THE **RWANDA** PATRIOTIC FRONT (RPF) THREATENS A CEASE-FIRE AND ONGOING NEGOTIATIONS BETWEEN THE GOVERNMENT AND THE INSURGENTS. IF NEGOTIATIONS BREAK DOWN, THE UNITED NATIONS COULD BE CALLED UPON TO MEDIATE BETWEEN THE TWO COMBATANTS. THE RPF ATTACKS COME AT A TIME WHEN THE GOVERNMENT IS STARTING TO MAKE CONCESSIONS TO THE INSURGENTS. INTERNATIONAL PRESSURE HAD SUCCEEDED IN FORCING PRESIDENT HABYARIMANA TO DISMISS OFFICIALS WHO WERE ENCOURAGING ETHNIC VIOLENCE. RENEWED WARFARE COULD LEAD TO THE RPF AND GOVERNMENT FORCES PARTICIPATING IN "ETHNIC CLEANSING" OF THEIR OPPONENTS, FURTHER EXACERBATING THE SITUATION. ~~(DECL OADR)~~
