(C) AS FIGHTING CONTINUED IN THE NORTH, THE GOVERNMENT REPORTEDLY CALLED FOR A 1-WEEK TRUCE STARTING AT MIDNIGHT ON 15 FEBRUARY. PEACE TALKS WILL RESUME BETWEEN THE **RWANDA** PATRIOTIC FRONT (RPF) AND THE GOVERNMENT IN THE NEAR FUTURE, ACCORDING TO A 14 FEBRUARY GOVERNMENT COMMUNIQUE. THE DATE HAS NOT BEEN SET, BUT THE TALKS COULD START WITHIN THE NEXT WEEK. THE COMMUNIQUE ADDS THAT THE TWO SIDES PLAN A MEETING IN TANZANIA AT THE HIGHEST POSSIBLE LEVEL AS EARLY AS CAN BE JOINTLY AGREED UPON. THE ANNOUNCEMENT FOLLOWS SEVERAL DAYS OF
