THE MILITARY REPULSED THE ATTACKS, WHICH LEFT TWO DEAD, AND SOLDIERS ARE STILL PURSUING THE REBELS IN BURUNDI'S NORTHWESTERN PROVINCES. HUTU REBELS OPERATING FROM **RWANDA** HAVE BEEN RESPONSIBLE FOR MOST OPERATIONS DIRECTED AGAINST THE TUTSI-DOMINATED BURUNDIAN MILITARY. THESE LATEST ATTACKS COULD JEOPARDIZE RECENT BURUNDI/RWANDAN EFFORTS TO IMPROVE RELATIONS.
