- 1. (C) KIGALI MAY BE MAKING GAINS IN ITS POLITICAL ASSAULT ON THE RWANDAN PATRIOTIC FRONT (RPF).
- 2. (C) THE RPF REMAINS STEADFAST ON ITS MAJOR DEMANDS FOR AN END TO THE FIGHTING. IT INSISTS THAT THE RWANDAN ARMY RESPECT THE CEASE-FIRE DECLARED EARLIER THIS YEAR, THAT AN INTERIM GOVERNMENT REPLACE PRESIDENT HABYARIMANA AS PART OF THE REFORM PROCESS, AND THAT ELECTIONS BE HELD. IN ADDITION, ALL REFUGEES MUST BE REPATRIATED AND RESETTLED SO THEY CAN PARTICIPATE IN FREE ELECTIONS, A NATIONAL CONFERENCE OF ALL POLITICAL FORCES IN THE COUNTRY MUST BE FORMED TO DETERMINE REFORMS, AND THE RPF MUST BE INTEGRATED INTO THE /****** BEGINNING OF SECTION 004 *******/
