IT IS UNCLEAR HOW IMPORTANT A ROLE HE PLAYED. BUT SEVERAL GENERALS CONSIDERED IN THE MONTESINOS CAMP WERE ASSIGNED TO INFLUENTIAL POSITIONS. WHILE SOME OF THE ASSIGNMENTS APPEAR TO BE BUSINESS AS USUAL. SOME ARE LESS PALATABLE TO OFFICERS WITH LESS POLITICAL INFLUENCE IN THE MILITARY AND POLITICAL HIERARCHY. THE MONTESINOS "PICKS" WILL UNDOUBTEDLY EVOKE CRITICISM - ALBEIT PROBABLY SILENT -FROM THE MONTESINOS OPPONENTS. SOME ASSIGNMENTS WILL SERVE AS REWARDS IN RECOGNITION OF OFFICERS EXCELLENT PERFORMANCE, ESPECIALLY DURING THE EARLY 1995 PE-EC BORDER CONFLICT AND THE HOSTAGE RESCUE AT THE JAPANESE AMBASSADOR'S RESIDENCY.
