TEXT: 1. (U) EXECUTIVE SUMMARY. SCIENTIFIC EXPERTS SENT A LETTER TO
SENIOR ISRAELI OFFICIALS CRITICIZING THE IRON DOME SHORT-RANGE ROCKETS DEFENSE SYSTEM. THEY CONTEND THAT IRON DOME CANNOT INTERCEPT KASSAM ROCKETS WHOSE IMPACT OCCURS AFTER 25 TO 30 SECONDS AND WHICH HAVE A RANGE UP TO 16 TO 18 KILOMETERS, LEAVING THE GAZA PERIPHERY TOWNS OF SDEROT, ASHKELON, AND NETIVOT DEFENSELESS. THE TEAM RECOMMENDED THE LASER-BASED SKYGUARD SYSTEM. IN CONTRAST TO THIS, THE MINISTRY OF DEFENSE EXPRESSED SATISFACTION WITH THE PROGRESS OF IRON DOME.

(U) WHILE THE ISRAEL AIR FORCE (IAF) IS SETTING UP A SPECIAL BATTALION THAT WILL OPERATE THE IRON DOME SHORT-RANGE ROCKET DEFENSE SYSTEM, A SERIES OF EXPERTS AND FORMER SENIOR OFFICERS SENT A STRONG LETTER TO THE ISRAEL DEFENSE MINISTER EHUD ((BARAK)) IN WHICH THEY SCATHINGLY CRITICIZE THE SYSTEM THAT IS EXPECTED TO BE DEPLOYED IN THE GAZA STRIP BY THE MIDDLE OF 2010. MEMBERS OF THE (QUOTE) MAGEN LA-OREF (UNQUOTE) ASSOCIATION (KNOWN IN ENGLISH AS THE HOME FRONT SHIELD), INCLUDING PHYSICISTS, LASER EXPERTS, AND OFFICERS IN THE RESERVES HAVE SENT A STRONG LETTER AGAINST THE DECISION TO PURSUE THE DEVELOPMENT OF THE RAFAEL-MADE IRON DOME. - 3. (U) THIS GROUP OF EXPERTS CONTEND THAT IRON DOME CANNOT INTERCEPT KASSAM ROCKETS WHOSE IMPACT OCCURS AFTER 25 TO 30 SECONDS AND WHICH HAVE A RANGE UP TO 16 TO 18 KILOMETERS (KM). THE EXPERTS WROTE (QUOTE) THIS IS THE MINIMAL TIME THAT'S REQUIRED IN ORDER TO DESTROY THE THREAT AFTER ITS LAUNCH. ANY THREAT THAT TAKES LESS THAN THAT WILL NOT BE INTERCEPTED. IT WILL STRIKE ITS TARGET BEFORE IRON DOME CAN REACH IT (UNQUOTE).
- 4. (U) THE EXPERTS ARGUE THAT THESE LIMITATIONS OF IRON DOME SHOULD HAVE BEEN EXPOSED AT A PREPARATORY STAGE BEFORE THE SYSTEM DEVELOPMENT STARTED. THE EXPERTS ARGUE THAT IRON DOME WILL NOT PROVIDE PROTECTION AGAINST ROCKETS AND MORTARS TO TOWNS LOCATED UP TO 16 KM AWAY FROM THE BORDER. THEY INDICATED (QUOTE) THE TOWNS IN THE GAZA PERIPHERY SDEROT, ASHKELON, AND NETIVOT WILL BE DEFENSELESS.
