(NFI).  
B. ~~(C//REL)~~ PAGE TWO, ASKED THE RECIPIENT TO INVESTIGATE A LETTER  
NUMBERED 3387, DATED 7 AUG 02. IT GIVES NO CLUE AS THE CONTENTS OF  
LETTER 3387. THIS MEMO IS SIGNED SIMPLY R.Q. (NFI).  
C. ~~(C//REL)~~ PAGE 3, AGAIN THE LETTER NUMBERED 3387 APPEARS; WHICH  
NOW REFERS TO THE INVESTIGATION OF A AL QAIDA ORGANIZATION MEMBERS  
PRESENT IN IRAQ. THIS MEMO STATES THERE IS NO INDICATION OF AL QAIDA  
IN HIS AREA OF RESPONSIBILITY. THIS PAGE IS SIGNED BY NAZIM ISMAEEL  
(MOHAMAD)).

F. ~~(C//REL)~~ PAGE SIX, MENTIONS THAT A RELIABLE SOURCE (NFI) CONFIRMED COOPERATION BETWEEN AL-KHAKAYLA AND AL QAIDA. THE MEMO ALSO NAMES USAMA BIN ((LADEN)), AND THAT THEY (NFI) POSSESS MORE THAN ONE PASSPORT. THE RECIPIENT OF THIS MEMO IS DIRECTED TO CONTINUE SURVEILLANCE OF THE GROUP IN HIS AREA OF RESPONSIBILITY (NFI). THE MEMO ALSO SAYS TO INVESTIGATE THE AL QAIDA CONNECTION, WITH REGARDS TO THE JORDANIAN COMMUNITY WITHIN HIS AREA AND REPORT TO M18. (FIELD COMMENT: M18 IS THE IRAQI DIRECTORATE OF IMMIGRATION AND RESIDENCY) THE MEMO GIVES THIS SUBJECT IMPORTANT PRIORITY. AGAIN THIS MEMO IS SIGNED SIMPLY R.Q.
