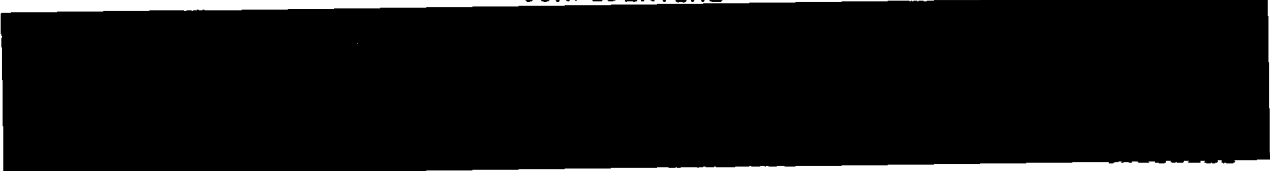

SUMMARY: (U) A SHIPMENT OF F-7 AIRCRAFT TO IRAN COMPLETED AN ORDER CONTRACTED FROM THE PRC. THE CHINESE ARE WORKING WITH IRAN ON TWO MISSILES, ONE WITH A 130 KM RANGE AND ONE WITH A RANGE OF 300-700 KMS.
