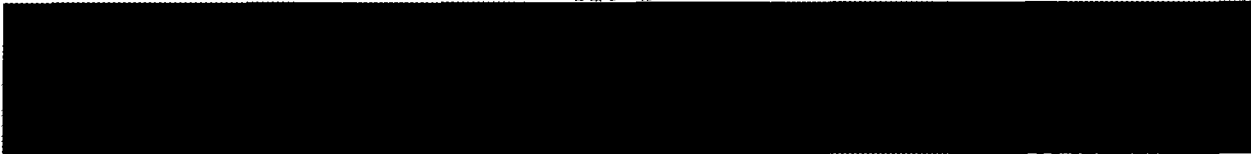

SUMMARY: (S/NF/NC) AN IRANIAN ARMS DELEGATION REMAINS  
IN BEIJING FOR DISCUSSIONS BETWEEN IRANIAN AIR FORCE  
REPRESENTATIVES AND XINSHIDAI ON THE PURCHASE OF F7 AND  
F8 AIRCRAFT. AN IRANIAN NAVAL DELEGATION WILL ARRIVE  
BEIJING ON 9 NOVEMBER 88.

[redacted] HASHEMI REMAINS IN BEIJING WITH AN IRANIAN DELEGATION.  
THE DELEGATION CONSISTING OF SIX OR SEVEN MEMBERS OF THE  
IRANIAN AIR FORCE IS CONTINUING DISCUSSIONS WITH XINSHIDAI  
REPRESENTATIVES ON THE PURCHASE OF CHINESE AIRCRAFT.
