SUMMARY: ~~(S/NF/NC)~~ IRAN HAS CONTRACTED WITH THE SHANGHAI FARMING, INDUSTRY, AND SCIENTIFIC CORPORATION FOR THE PURCHASE OF 250 FISHING BOATS. IRAN ATTEMPTED TO NEGOTIATE THE PURCHASE OF 25 MD82 AIRCRAFT AND MAINTAINS INTEREST IN IMMEDIATE PURCHASE OF F7M AIRCRAFT.

TEXT: 1. ~~(S/NF/NC)~~ DURING DISCUSSIONS WITH (b)(1),1.4 (c) ON THE SPECIFIC RESULTS OF THE ((HASHEMI)) VISIT TO BEIJING IN EARLY NOVEMBER, (b)(1),1.4 (c) THAT WITH THE EXCEPTION OF AN AGREEMENT TO PURCHASE 250 FISHING BOATS FROM A SHANGHAI COMPANY, NO MAJOR DEAL FOR ARMS WAS COMPLETED. IRAN REPORTEDLY CONTRACTED THROUGH TAGELL WITH THE SHANGHAI FARMING, INDUSTRY, AND SCIENTIFIC CORPORATION FOR THE PURCHASE OF THE 120 FOOT CRAFTS CAPABLE OF SPEEDS UP TO FIFTEEN KNOTS AND A SUSTAINED RATE OF SPEED OF 6-7 KNOTS. THE SHANGHAI CORPORATION HAS JUST BEGUN THE BUILDING OF THE BOATS AND NONE HAVE BEEN DELIVERED TO DATE. (b)(1),1.4 (c) DID NOT HAVE INFORMATION ON THE PRICE OR DELIVERY DATES FOR THE FIRST SHIPMENT.

2. ~~(S/NF/NC)~~ IRAN ATTEMPTED TO CONVINCE CAAC TO TAKE DELIVERY OF THE MD82 AIRCRAFT CURRENTLY BEING ASSEMBLED IN SHANGHAI AND DIVERT THE AIRCRAFT TO IRAN. APPARENTLY, CAAC COULD NOT FIND ANY POSSIBLE METHOD TO CAMOUFLAGE THE SALE AND REFUSED TO DISCUSS THE SALE WITH THE IRANIAN REPRESENTATIVES. APPARENTLY, THIS IDEA WAS FLOATED BY THE LOCAL REPRESENTATIVE FOR CAAC (LOFTECH), MS ((ZHENG)) LIMING WHO IS DEVELOPING A HIGH PROFILE FOR HER SINGLE MINDED ENTHUSIASM TO MAKE A SALE AND HER LACK OF DISCRETION AND CONCERN FOR THE POTENTIAL EMBARRASSMENT OF HER CLIENTS.

3. ~~(S/NF/NC)~~ IRAN REMAINS INTERESTED IN THE IMMEDIATE PURCHASE OF 50 F7M AIRCRAFT. NO DETAILS ON THE RESULTS OF NEGOTIATIONS FOR THIS AIRCRAFT WERE REPORTED.

COMMENTS: ~~(S/NF/NC)~~ (b)(1),1.4 (c) IS RELATIVELY AMUSED BY THE BLATANT ATTEMPTS BY MS. ZHENG TO FINALIZE ANY AND ALL MILITARY SALES TO IRAN. APPARENTLY, MS ZHENG IS SENDING TELEXES AROUND THE WORLD DESCRIBING THE MATERIAL DESIRED BY THE IRANIAN CLIENTS. (b)(1),1.4 (c) WAS ALSO VERY PESSIMISTIC ABOUT IRAN'S CHANCES OF OBTAINING THE F7M AIRCRAFT IN THE NEAR TERM.
