1. ~~(S)~~ TRANSPORT ACTIVITY BETWEEN CUBA AND ANGOLA HAS EXPANDED IN THE LAST SEVERAL WEEKS. CUBA'S CIVIL AIRLINE HAS FLOWN AN INCREASED NUMBER OF FLIGHTS BETWEEN HAVANA AND LUANDA. IN ADDITION, THE WEEKLY ANGOLAN AIRLINE FLIGHT HAS CONTINUED AS SCHEDULED. CUBAN MILITARY-ASSOCIATED MERCHANT SHIPS ALSO ARRIVED RECENTLY IN LUANDA.

2. ~~(S)~~ THERE IS NO INFORMATION TO CONFIRM WHO OR WHAT WAS ON BOARD THE PLANES OR SHIPS. LIKELY EXPLANATIONS INCLUDE: CIVILIAN ADVISERS FOR ETHIOPIA AND ANGOLA; TROOP REPLACEMENTS TO THESE COUNTRIES;
