THE TOWN OF FAMAILLA (27035-6524H) ON 5 NOV 70. THE ATTACK WAS: MADE BY A-48 S OF THE V AIR BRAGADE AT VILLA REYNOLDS (33438-6523W). AND WAS LED BY THE BRIGADE DIRECTOR OF OPERATIONS (EQUIVALENT TO A USAF HING DO! COMODORO "CACHO" GIOSA. 2. (U) HEATHER DURING THE STRIKE, WHICH BEGAN AT 1308Z, HAS 506 TARGET ACQUISITION. METERS BROKEN AND DID NOT INTERPERE WITH VISUAL FRAGMENTATION BOMBS WERE DROPPED AND THEN STRAFING PASSES WITH 20MM CANNON HERE HADE UNTIL AMMUNITION WAS EXHAUSTED. STRIKE COORDINATION INVOLVED PRE AND POST STRIKE AERIAL PHOTOGRAPHY, PRE-STRIKE TARGET MAKING WITH SHOKE, AN AIR COORDINATOR ON THE GROUND AND AN AIRBORNE ON-SITE COMMANDER. 3' -(G) THE GUERRILLA BASE CAMP ATTACKED, WHICH WAS LOCATED IN A HEAVILY FORESTED BOX CANYON, HAD BEEN UNDER OBSERVATION BY PATROLS OF THE ARGENTINE ARMY'S V INFANTRY BRIGADE, RESPONSIBLE FOR THE COUNTER-GUERRILLA OPERATONS IN THE TUCUMAN PROVINCE, ONE SOURCE REPORTED THAT THE PATROLS HAD OBSERVED STRUCTURES AND PERSONNEL.
