IN USG ACTIONS OR POLICY. GRANTED THAT IN THEIR EFFORTS TO RATIONALIZE THEIR CURRENT DILEMMA THE ARGENTINE, IN GENERAL, REFUSES TO ACCEPT ANY RESPONSIBILITY OR CULPABILITY FOR PAST ACTIONS. ALTHOUGH LOOKING INTO ARGENTINA FROM THE OUTSIDE WE IN THE U.S. CAN SEE AS FOOLISH AND EVEN CHILDISH, BUT TO THE AVERAGE ARGENTINE CITIZEN, THESE PERCEPTIONS AND THOUGHTS ARE VERY REAL AND VIRTUALLY UNDENIABLE TRUTHS. AS A NATION [redacted] SEES ARGENTINA AS LIVING IN A DREAM WORLD. EVERY INTERNATIONAL PRO-ARGENTINE PRESS ITEM RECEIVES FRONT PAGE NOTICES. ARTICLES OR OPINIONS TO THE CONTRARY ARE RESERVED FOR ONE OR TWO COLUMNS ON THE EDITORIAL PAGES. THE AVERAGE ARGENTINE SEES HIMSELF AS EXTREMELY RIGHTEOUS, UPRIGHT, AND KNOWLEDGEABLE IN MOST MATTERS. IN FACT THE DEPTH OF UNDERSTANDING OF INTERNATIONAL SITUATIONS HERE IN ARGENTINA IS VERY SHALLOW INDEED. VIRTUALLY TO A MAN THE ARGENTINE MILITARY BELIEVE THEMSELVES TO BE THE PRIDE AND PROGENITOR OF ALL OF THE LATIN AMERICAN ARMED FORCES. THIS PERCEPTION HAS RECEIVED MUCH STROKING DURING AND SUBSEQUENT TO THE SOUTH ATLANTIC CONFLICT. ANY NEGATIVE INDICATIONS TO THIS PERCEPTION ARE QUICKLY FORGOTTEN OR PUSHED SO FAR ASIDE AS TO HAVE NO BEARING ON IT. SOLIDARITY OF LATIN AMERICAN COUNTRIES IS THE BYWORD AND IN THE OPINION OF THE ARGENTINE THE LEADERSHIP IN THIS SOLIDARITY BELONGS TO THE ARGENTINE.

NOT HESITATE TO REPEAT A "PROVEN" TACTIC REGARDLESS OF INTERNATIONAL OPINION. THIS IMPRESSION DOES NOT COME TO FROM THE MILITARY ALONE BUT COLLECTIVELY FROM ALL WALKS OF ARGENTINE SOCIETY.

B. [REDACTED] WITH RESPECT TO USG ACTIONS ON THE HUMAN RIGHTS ISSUE, THERE IS ANOTHER COMMON PERCEPTION HELD BY ANY IF NOT A MAJORITY OF THE ARGENTINES THAT THE USG IS TOTALLY LACKING IN UNDERSTANDING OF ARGENTINA OR THEY WOULD NOT BE TRYING TO "IMPOSE" FOREIGN IDEOLOGY IN THE FORM OF HUMAN RIGHTS EDICTS, MORES, AND MORALS.

[REDACTED] BY AND LARGE THE ARGENTINE HAS NO PROBLEM WITH EITHER DEFINITIONS OF HUMAN RIGHTS OR INTERNATIONAL BASIS OR THE BASIC TENETS ON WHICH THEY ARE FOUNDED. WHAT THEY DO HAVE DIFFICULTY WITH IS THEIR BEING SANCTIONED BY THE U.S. AND ONLY THE U.S. THEY SEE THESE POLICIES AS BEING VERY UNEVENLY ENFORCED AND HAVE THE CONCEPTION THAT THE HEAVIEST HAND FELL ON ARGENTINA. [REDACTED] FEELS THAT THE ARGENTINE RESENTS MUCH MORE THE IMPOSITION OF THE ACT THAN ANY REAL LOSSES THAT RESULTED FROM ITS IMPOSITION.

C. [REDACTED] THREE POINTS IN SUPPORT OF [REDACTED] OPINION FOLLOWS: (1) THE MOTHERS OF THE PLAZA DE MAYO HERE IN ARGENTINA HAVE VIRTUALLY NO INFLUENCE, AND THE MAJORITY OF THEIR SUPPORT IS FROM OUTSIDE OF ARGENTINA. THE AVERAGE ARGENTINE SHOWS VERY LITTLE INTEREST IN THEIR CAUSE. (2) THIS GOVERNMENT RECENTLY PASSED THE AMNESTY LAW COVERING THE ACTIONS OF THE PERIOD 1973-82 AND ALTHOUGH THERE ARE RUMBLINGS OF UNCONSTITUTIONALITY FROM SOME POLITICAL AND JUDICIAL CIRCLES, THERE IS STRONG CONSENSUS THAT THE LAW AS PROMULGATED WILL PROVE TO BE EFFECTIVE IN ITS INTENDED PURPOSE WHICH IS TO SHIELD THOSE WHO CARRIED OUT THE ANTI-TERRORIST ACTIONS OF THE STATE DURING THIS PERIOD. (3) ON THE HEELS OF THE AMNESTY LAW CAME A SECOND LAW, THE ANTI-TERRORIST LAW. THIS LAW IS KEEPING MORE BT

MONTHS TO CULTIVATE THESE BELIEFS SINCE THE CONFLICT, THE ANTI-U.S. SENTIMENTS ARE PRESENTLY VERY STRONG. WHEN THESE FEELINGS ARE FURTHER INCITED BY THE RESTRICTIONS IMPOSED BY THE HUMPHREY-KENNEDY AMENDMENT OVER HUMAN RIGHTS VIOLATIONS, THE TERRIBLE OVERALL STATE OF THE ARGENTINE ECONOMY (ALSO PERCEIVED AS THE FAULT OF U.S. INTERNATIONAL POLICIES), AND THE BURDEN OF BEARING THE THIRD LARGEST EXTERNAL DEBT IN THE WORLD (WHICH MANY IN ARGENTINA BELIEVE IS OWED ONLY TO THE U.S.), IT IS NO UNDER THAT U.S./ARGENTINE RELATIONS ARE ON THE DOWN SIDE. THE ARGENTINES, IN THEIR NATIVITY AND IN THEIR RIGHTEOUS PERCEPTION OF THEMSELVES, ARE CONVINCED THAT THEY NEED BUT TO STATE THEIR CASE AND RIGHT WILL WIN IN THE END. [REDACTED] MANY ARGENTINES WHO HAVE ACTUALLY RETURNED FROM VISITS TO THE U.S. CONVINCED TO THE CORE THAT THE USG/DOD ARE 100 PERCENT BEHIND THEIR OBJECTIVES. IT IS ALMOST IMPOSSIBLE TO DESCRIBE HOW THESE PEOPLE IN GENERAL ARE ABLE TO SEE AND TO HEAR ONLY THAT WHICH SUITS THEIR OBJECTIVES AND NOT TO SEE OR NOT TO HEAR ANYTHING TO THE CONTRARY.

2. (U) HUMAN RIGHTS ISSUE:

A. [REDACTED] IF THE INTENT OF THE HUMPHREY-KENNEDY RESTRICTIONS IMPOSED ON THE CURRENT MILITARY REGIME WAS ONLY TO RECTIFY THE IMMEDIATE AND APPARENT VIOLATIONS IN EXISTENCE AT THE TIME IT WAS IMPOSED THEN [REDACTED] CAN SAY WITH CONVICTION IT WAS SUCCESSFUL. HOWEVER, IF THERE WERE ANY UNDERLYING DESIRES TO EDUCATE THE ARGENTINE PEOPLE THAT SUCH ACTIONS AS WERE USED CAN NOT NOR WILL NOT BE TOLERATED BY THE CIVILIZED WORLD COMMUNITY, THEN [REDACTED] CAN ALSO SAY WITH CONVICTION THAT THE HUMPHREY-KENNEDY LEGISLATION FELL FAR SHORT OF THE MARK. THE ARGENTINE POLITICIAN, ARGENTINE MILITARY, AND THE ARGENTINE MAN-ON-THE-STREET THINK (IN BY FAR THE GREATER MAJORITY) THAT THE ACTIONS TAKEN BY THE ARMED FORCES IN 1975-78 WERE ESSENTIAL, EXPEDIENT, AND ULTIMATELY SUCCESSFUL. THE CONSENSUS OPINION IS THAT THE MILITARY IN GENERAL WANT THE PERONIST FACTIONS TO WIN THE ELECTIONS. ALTHOUGH [REDACTED] KNOWS PERSONALLY SOME VERY SENIOR OFFICIALS WHO ARE STRONG SUPPORTERS OF THE RADICALS, THE MAJORITY BELIEVE THAT ONLY THE PERONISTS, WITH THE SUPPORT OF THE LABOR MOVEMENT AND THE MILITARY, WILL HAVE EVEN THE SLIGHTEST CHANCE OF SURVIVING A SIX-YEAR TERM.
