THE THO GUERRILLA HELICOPTERS REPORTEDLY OPERATING IN THE A.O. HE ENVISIONED THE NIGHT USE OF HIGH PERFORMANCE AIRCRAFT, EQUIPPED WITH RADAR. THE GENERAL PLANNED TO DRBIT THEAIRCRAFT UNTIL THE HELICOPTERS APPEARED AND THEN DESTROY THEM. THE COMMANDER WAS INFORMED BY THE STAFF THAT HIS REQUEST HAD BEEN FORMARDED TO THE NAVY. BUT AS YET, NO ANSWER HAS BEEN RECEIVED.

3. Sec. 3.3(b) (1) CTNFUT IT IS APPARENT THAT THE EXECUTION OF THE TUCUMAN OPERATION IS A FRUSTRATING EXPERIENCE TO FIELD COMMANDERS. THE REQUEST FOR AIR SUPPORT REFLECTS THE CONTIN-UING LACK OF JOINT OPERATIONAL PROCEDURES WITHIN THE ARGENTINE ARMED FORCES. PURTHERMORE, IT IS CURIOUS THAT THE ARMY GENERAL STAFF HAS REQUESTED SUPPORT FROM THE NAVY (PEHHAPS IT HAS POLITICALLY HOTIVATED) WHEN THE AIR FORCE HAS AVAIABLE AIRCRAFT IN THE A.O. AT ANY RATE, THE WHOLE CONCEPT OF USING HIGH PERFORMANCE AIRCRAFT FOR NIGHT DETECTION OF HELICOPTERS WITHOUT SOPHISTICATED EQUIPMENT (LOOKDOWN RADAR OR IR) 18 QUESTIONABLE AND TO THE BEST OF OUR KNOWLEDGE NO SUCH HARDHARE EXISTS IN THE ARGENTINE INVENTORY. THIS IS BUT ABOTHER INDICATOR THAT THE ARMY IS GOING TO BE FORCED TO GO ALONE WITH LITTLE OR IND SUPPORT FROM THE INTHER BERVICES BE GOVERNMENT AGENCIES, WITH REGARD TO PRISONERS, THERE IS CITTLE DOUBT THAT FIELD COMMANDERS VIEW THEM AS A LIABILITY, ALTHOUGH COMMANDERS APPARENTLY MAVE NOT RECEIVED TFFICIAL ORDERS TO KILL POW'S, THEY PREPER TO DO SO AFTER THEY HAVE BEEN PULLY EXPLOITED, THERE HAVE BEEN TWO EXPLANATIONS FOR THIS, FIRST, ARGENTINE OFFICERS HOULD RATHER HISK THE EFFECTS OF GUERRILLA PROPAGANDA CAMPAIGNS THAN FACE THE POSSIBILITY OF A DIPLOMATIC KIDNAPPING AND SUBSEQUENT HOSTAGE SITUATIONS. SECOND, THEY BELIEVE THAT LEFTISTS IN THE GOVERNMENT HIGHT EVENTUALLY CAUSE THE RELEASE OF CAPTURED TERRORISTS AND THEY (THE ARMY) HOULD HAVE TO FIGHT THEM AGAIN. NOT ALL ARGENTINE OFFICERS ARE IN AGREEMENT WITH THE PRESENT INTERROGATION METHODS EMPLOYED BY THE TUCUMAN FORCES, SOME INTELLIGENCE OFFICERS BELIEVE THAT THE PON S
