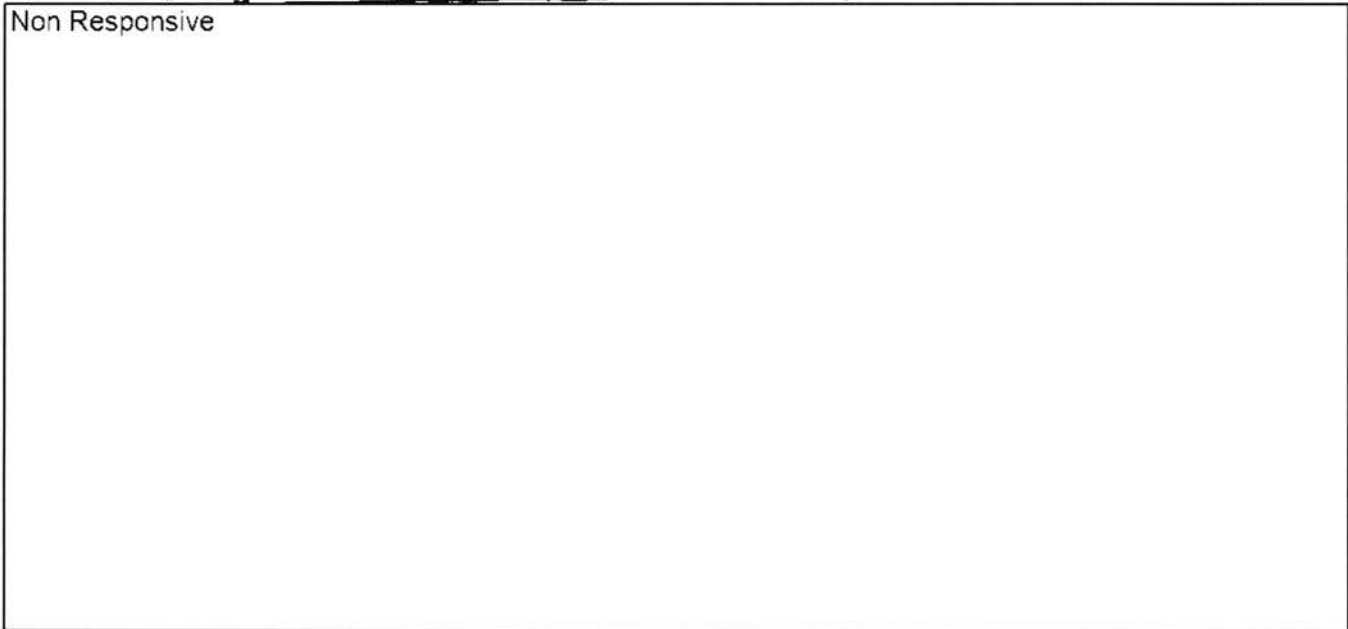

ITEM SEVEN: ARGENTINA (AS OF 1948 EDT 27 MAR 75)
1. ~~(S/NFD)~~ MOMENTUM BUILDS TO OUST WELFARE MINISTER. ORGANIZED LABOR, BACKED BY OTHER KEY POLITICAL SECTORS, HAS LAUNCHED AN ALL-OUT OFFENSIVE TO PRESS MRS. PERON INTO REMOVING HER CONFIDANT, WELFARE MINISTER LOPEZ REGA. RESENTMENT OF HIM AND HIS PREPONDERANT INFLUENCE HAS BEEN GROWING SINCE MRS. PERON BECAME PRESIDENT. KEY CONGRESSIONAL LEADERS, THE MILITARY, SOME CABINET OFFICIALS, AND THE LEADERSHIP OF THE MAJOR OPPOSITION PARTY APPARENTLY HAVE DECIDED TO ALLOW LABOR TO SPEARHEAD THE CAMPAIGN. IN ADDITION TO THE IMMEDIATE TARGET, THE CURRENT LABOR MOVE ALSO REPRESENTS A CONCERTED ATTEMPT TO INCREASE ITS ROLE IN GOVERNMENT.

A LABOR COMMUNIQUE RELEASED 24 MARCH REAFFIRMED LOYALTY TO THE PRESIDENT BUT DIRECTED VEILED CRITICISM AGAINST LOPEZ REGA AND POSSIBLY OTHER MINISTERS. IT ALSO DEMANDED BROAD LABOR PARTICIPATION IN GOVERNMENT AND AN EF-
