ARGENTINA: ATTACK ON OFFICIAL'S HOUSE. (U)

(U) EARLY ON 27 SEPTEMBER, THE RESIDENCE OF ECONOMY MINISTRY OFFICIAL WALTER KLEIN, TOP AIDE TO CONTROVERSIAL ECONOMIC MINISTER MARTINEZ DE HOZ, WAS ATTACKED AND BOMBED.

(U) THE HOUSE WAS REPORTEDLY BESIEGED BY ABOUT A DOZEN MEN DRESSED IN OLIVE-GREEN FATIGUES AND ARMED WITH AUTOMATIC WEAPONS. FOLLOWING A SKIRMISH WITH RESIDENCE GUARDS, THEY PLACED SEVERAL BOMBS ON THE PREMISES, WHICH DEMOLISHED THE STRUCTURE. KLEIN WAS NOT SERIOUSLY INJURED, BUT HIS WIFE AND THREE CHILDREN WERE HOSPITALIZED.
