SUMMARY: ~~(S/NOFORN)~~ ARGENTINE ARMY HEADQUARTERS HAS REQUESTED THAT ALL PERSONNEL AT THAT LOCATION INCREASE SECURITY VIGILANCE ON FOUR SPECIFIC DATES DURING THE MONTH OF JULY 1978, SUCH ACTION INDICATES THAT THE ARGENTINE ARMY STILL SEES A POTENTIAL THREAT FROM SUBVERSIVE GROUPS OPERATING IN ARGENTINA.

A. 1 JUL 78 - ANNIVERSARY OF THE DEATH OF JUAN PERON

B. 19 JUL 78 - ANNIVERSARY OF THE DEATH OF GUERILLA LEADER ROBERTO MARIO SANTUCHO

C. 26 JUL 78 - ANNIVERSARY OF THE DEATH OF EVA PERON

D. 31 JUL 78 - ANNIVERSARY OF THE DEATH OF CONGRESSMAN (DISPUTADO NACIONAL) ORTEGA PENA

COMMENTS: ~~(S)~~ WHILE NO DEFINITE INFORMATION IS AVAILABLE THAT SUBVERSIVE GROUPS IN ARGENTINA HAD OR HAVE ANY PLANS TO ACT AGAINST THE ARGENTINE ARMY ON THOSE DATES, THE FACT THAT DEPARTMENT HEADS AND CHIEFS OF SECURITY WILL BE EXERCISING MORE STRINGENT SECURITY MEASURES ON THE DATES MENTIONED INDICATES THAT THE ARGENTINE ARMY SEE SUBVERSIVE GROUPS OPERATING IN ARGENTINA AS BEING A CONTINUOUS THREAT TO ITS PERSONNEL AND INSTALLATIONS.
