IN THE PROCESS, HUMAN RIGHTS HAS BECOME A POLITICAL ISSUE BETWEEN THE PERONISTS AND THE GOVERNMENT AS THE FORMER PUBLICLY BELABORED THE LATTER FOR BEING BOTH "DE FACTO" AND ABUSING HUMAN RIGHTS (BUENOS AIRES 7559), AND THE GOVERNMENT WEIGHED IN WITH A WITHERING RESPONSE. THERE HAS BEEN ONE REPORTED DISAPPEARANCE IN SEPTEMBER. THE CONTROVERSIAL LAW ON PRESUMPTIVE DEATHS (BUENOS AIRES 7565) HAS BEEN PROMULGATED. SUBJECT: Information Received from GOA Military Intelligence

RSO Blystone met today with members of the Argentine military intelligence. [Sources advised that they have just learned that between ten and fifteen Montonero members have entered the country recently] and are assumed to be in the Cordoba area. [Sources believe this is the first part of a group of thirty who will be re-entering Argentina.] [Sources stated that these forces were trained in Angola] and that the second group, which is called TIE (Tropas de Infanteria Especiales, or Special Infantry Troops), has yet to enter the country.] This second group is expected to remain in the Buenos Aires area with the members presumed to be in Cordoba joining them later.] Sources expect the Montonero group to use the RPG-7 portable rocket launcher as they previously used approximately a year ago. Military sources believe they will use the same system, wherein a vehicle with a sunroof will be used to pass a target. The terrorist will fire the rocket launcher from the moving vehicle at the selected target and then escape. Sources stated that they expect the individuals to enter the country as normal tourists or as commercial-type visitors using Italian or French passports. Their intelligence indicates that the Montoneros are studying the Italian and French languages in order to pass as these nationalities; it is also possible that they will use Spanish passports. Sources stated that they do not know where their superiors obtained this information, but consider the information to be valid.

Our sources also advised that some time ago, GOA forces picked up an individual believing him to be a member of the Montoneros. During the interrogation, the forces discovered that the individual was a high-ranking member of FAP. The forces were surprised to learn he was a member of FAP, inasmuch as they considered FAP to be disbanded and no longer active in Argentina. The FAP member, under interrogation, advised the security forces that a cell of FAP members had gone underground a few years ago and have remained dormant, waiting for the opportunity to assert themselves. KLEIN--ONE OF MORE OF WHOM APPEARED TOTALLY UNRESPONSIVE TO THE ATTACKERS AS A RESULT OF THE INITIAL SHOCK OF THE ATTACK ITSELF) AND ENGAGED IN A GUN BATTLE WITH THE TWO GUARDS WHO REMAINED ALERT TO THE SITUATION. THESE TWO GUARDS FIRED AT THE ATTACKERS, BUT WERE KILLED BY MACHINEGUN FIRE. learned from the FAP member where they had stored their weapons, which have subsequently been confiscated. Some of the disappearances during August may be related to the discovery of this group. Sources advised that it is possible that a number of these members may reappear under PEN at a later date or may not reappear at all.

* Sources confirmed that in July, in Buenos Aires Province, while tilling his field, a farmer discovered a small number of weapons buried there and notified the Argentine Air Force. Security forces determined that the weapons had been in the ground for approximately two to three years and were not usable.

RSO was advised today through a contact in the Federal Security Police that Comisario Fioravanti, two subcomisarios, and two police officials were apprehended 20 days ago for committing six acts of criminal kidnapping, with ransoms ranging into the millions of dollars. The names of those involved and details of this case will follow in a separate report.

Other sources also advised that Comisario Inspector Repetto has been named as the new Chief of Intelligence for Metropolitan Security. This is a new position and many of the police officials do not understand why he was chosen, as Repetto is known to have been involved in many criminal activities.

(1) HE INDICATED THAT THE TRAINING WAS SUBDIVIDED INTO SEPARATE COURSES WHICH WERE BEING CONDUCTED IN LEBANON.

- COURSE ONE: INDIVIDUALS IN THIS COURSE RECEIVED NO MILITARY PREPARATION. THEY LATER SERVED AS CONTACTS AND COURIERS. THE COURSE IS 30-DAYS IN DURATION AND THERE ARE BETWEEN SIX (6) AND SEVEN (7) STUDENTS IN THE COURSE AT ONE TIME.

- COURSE TWO: THIS COURSE IS DESIGNED TO TRAIN "TEI" PERSONNEL AND IS ALSO 30-DAY IN DURATION. STUDENTS RECEIVE INSTRUCTION IN ARMS, MARKSMANSHIP, AND SPECIAL OPERATIONS (TO INCLUDE EXPLOSIVES). TEN (10) STUDENTS ARE TRAINED IN THE COURSE AT ONE TIME.

- COURSE THREE: THIS COURSE IS DESIGNED TO TRAIN "TEA" PERSONNEL AND, AGAIN, IS 30-DAYS IN DURATION. STUDENTS ARE INSTRUCTED IN THE THEORETICAL AND TECHNICAL ASPECTS OF RADIO/TELEVISION TRANSMISSION. THERE ARE APPROXIMATELY SIXTEEN (16) STUDENTS IN THE COURSE AT ONE TIME.

(2) IN EXPLAINING THE COURSE MATERIAL, SOURCE INDICATED THE FOLLOWING:

- ARMAMENT INSTRUCTION INCLUDED CHARACTERISTICS OF VARIOUS TYPES OF WEAPONS, ASSEMBLY/DISSEMBLY, MAINTENANCE, AND METHODS USED TO HIDE AND TRANSPORT WEAPONS. LIVE FIRING EXERCISES ARE CONDUCTED USING ALL AVAILABLE WEAPONS.

- SPECIAL OPERATIONS TRAINING INCLUDES TYPICAL COMMANDO "HIT AND RUN" TYPE INSTRUCTION, WHICH EVENTUALLY LEADS TO A PRACTICAL EXERCISE BEING CONDUCTED BY THE WHOLE GROUP.

- EXPLOSIVES TRAINING IS DESIGNED TO INSTRUCT THE STUDENTS IN THE DIFFERENT CLASSES OF EXPLOSIVES, DESTRUCTIVE POWERS, AND UTILIZATION. "TNT" IS USED EXTENSIVELY IN THE INSTRUCTION.

- ELECTRONICS TRAINING GIVES INSTRUCTIONS ON HOW TO INTERRUPT TV TRANSMISSION AND THE TECHNICAL ASPECTS OF THESE TRANSMISSIONS.

THE FOLLOWING AMPLIFYING INFORMATION CONCERNING MONTONERO TRAINING, MOVEMENT, AND PLANS:

(1) ACCORDING TO SOURCE, IN 1979 (NFI) APPROXIMATELY 100 TO 200 INDIVIDUALS FROM ARGENTINA WENT TO VARIOUS TRAINING BASES IN LATIN AMERICA AND EUROPE FOR INCORPORATION IN THE MONTONERO MOVEMENT. HE INDICATED THAT HE KNEW OF THREE INDIVIDUALS WHO HAD BEEN RELEASED FROM CONFINEMENT UNDER THE RIGHT OF OPTION PROGRAM WENT ABROAD AND RETURNED TO ARGENTINA AS MONTONEROS. THE 100 TO 200 INDIVIDUALS (EXACT NUMBER UNKNOWN) WENT TO VARIOUS LOCATIONS.

(2) THE ONES WITH NO PREVIOUS CONNECTIONS TO THE MONTONERO MOVEMENT (I.E., NO POLITICAL INDOCTRINATION) WERE SENT TO A BASE IN MEXICO. SOURCE INDICATED THAT HE KNEW OF AT LEAST 25 WHO WENT TO THIS TRAINING BASE. AT THE BASE THEY WERE INSTRUCTED IN PROPAGANDA, MONTONERO PHILOSOPHY, ETC. TO HIS KNOWLEDGE, NO REAL MILITARY TRAINING TOOK PLACE AT THIS LOCATION. THE INDIVIDUALS WITH THE GREATEST POTENTIAL FROM THIS GROUP OF 25 WERE SENT TO LEBANON FOR TRAINING IN COMBAT OPERATIONS AS DESCRIBED BY SOURCE "B".

(3) SOURCE INDICATED THAT VARIOUS LOCATIONS IN AFRICA, LATIN AMERICA, AND EUROPE WERE USED AS TRAINING BASES. MONTONERO COMBAT ELEMENTS WERE TRAINED IN ANGOLA AND HAD BEEN ACTUALLY UTILIZED IN COMBAT OPERATIONS AGAINST ELEMENTS OPPOSED TO THE MARXIST REGIME THERE.

(4) SOURCE INDICATED THAT PROPAGANDA AND INTELLIGENCE TRAINING WAS RECEIVED IN CZECHOSLOVAKIA. (SOURCE COULD NOT SAY WHO WAS DOING THE TRAINING).

(5) SOURCE RELATED THAT INDIVIDUALS ALSO RECEIVED TRAINING IN SPAIN AND ALGERIA. HE DID NOT HAVE EXACT NUMBERS OF INDIVIDUALS TRAINED IN EACH COUNTRY, BUT DESCRIBED HIS INFORMATION AS EXTREMELY ACCURATE AS TO THE COUNTRIES INVOLVED.

(6) WITH THIS, HE MOVED BACK TO LATIN AMERICA AND STATED THAT NUMEROUS MONTONEROS WERE (AT ONE TIME) INCORPORATED INTO THE SANDINISTA MOVEMENT AND FOUGHT ALONGSIDE THE SANDINISTAS IN THEIR FIGHT AGAINST ((SOMOZA)). WITH THIS, HE MENTIONED THAT THE MONTONEROS LOANED 25-MILLION DOLLARS TO THE SANDINISTA MOVEMENT PRIOR TO SOMOZA'S DOWNFALL. PART OF THE MONTONEROS WHO WENT TO NICARAGUA WERE ALSO TRAINED IN CUBA.
