His principles seem to be dominated by his anti-communist attitude. Camps was involved in the jailing and investigation of Joseph Timerman. Close to Maj Gen Suarez Mason, present Chief of Staff of the Army. Both appear to sing off the same sheet of music as being among the hardest of the hard liners.</p> <p>His hard line attitude against terrorists and communists brings him in conflict with US foreign policy in the area of human rights. Within his own channels he is probably outspoken against the US in this respect. He is the type of Argentine Army officer who would relish a return to the US/Latin America policy of the early 1960's. Again allegedly has eliminated many terrorists while Chief of Police of Buenos Aires province. Has stated that the war against subversives can not be fought using conventional methods. Said by some to be anti Videla/Viola and pro Suarez Mason in his alignment within the Army.
