SOURCE SAID THAT THERE HAVE BEEN SIGNS THAT THE CHILEANS ARE MOBILIZING CIVILIAN AND MILITARY PERSONNEL IN THE ANDEAN REGION OF PATAGONIA. HE SAID THAT RECENTLY THE CHILEANS HAD CAUSED 2500 OF THEIR NATIONALS WORKING IN ARGENTINA TO RETURN TO CHILE. THE IMPLICATION SOURCE MADE AS THAT THESE PEOPLE WOULD BE PART OF A FORCE THE CHILEANS WOULD USE AGAINST ARGENTINA.

2. (G/NOFORN) SOURCE WENT ON TO SAY THAT THE ARGENTINE ARMED FORCES ARE WELL AWARE OF ALL CHILEAN ACTIONS IN THE BORDER AREA, AND ARE READY TO TAKE ARMED RETALITORY ACTION IF NECESSARY.
