16. SUMMARY: (SANOFSHN) Sec. 3.3(b) (1)

THAT NUMBER OF PEN DETAINEES IS SLIGHTLY UNDER 4000. OF THESE,

3000 WILL BE RELEASED. BUT THE REMAINING 1000 WILL HAVE TO BE

THAT NUMBER OF PEN DETAINES IS SLIGHTLY UNDER 4000. OF THESE, 3000 WILL BE RELEASED, BUT THE REMAINING 1000 WILL HAVE TO BE DETAINED FOR AN INDEFINITE PERIOD. ORDERS HAVE REEN GIVEN TO CEASE UNAUTHORIZED COUNTER TERRORIST OPERATIONS, BUT SOME INDIVIDUALS OF SECURITY FORCES ARE NOT COMPLYING. THEY WILL BE DEALT WITH SEVERELY.

HE ADMITTED THAT THERE HIGHT BE A PROBLEM FINDING COUNTRIES TO ACCEPT MOST OF THE DETAINEES SINCE ONLY A VERY SMALL NUMBER, PERHAPS NO MURE THAN 100, OF THE 4000 BEING HELD HAD NOT BEEN DIRECTLY INVOLVED IN TERRORISM AND SUBVERSION, WHEN RO REGISTERED SURPRISE AT THE 4000 FIGURE AND SUGGESTED THERE MIGHT BE SEVERAL THOUSAND MORE, SOURCE INSISTED THAT THE NUMBER HELD UNDER PEN IS JUST UNDER 4000.

2. (EXMODURN) RETURNING TO THE DISPOSITION OF THE 4000 PEN DETAINEES, SCURCE ESTIMATED THAT ABOUT 3000 WOULD BE RELEASED. THE DISPUSITION OF THE REMAINING 969 TO 1000, HOWEVER, POSED A SERIOUS PROBLEM FOR THE GOVERNMENT. THESE ARE ALL HARD-CORE TEHRUPISTS WHO EXERCISED LEADERSHIP POSITIONS AND ON WHOM THE GOVERNMENT HOLDS EXTENSIVE AND CONFIRMED INTELLIGENCE INFOR-MATION. HANY OF THEM HAVE "BLOOD ON THEIR HANDS". Sec. 3.3(b) (1 THAT SOME OF THESE WILL BE TRIED IN COURTS OF LAW, BUT IN MUST CASES THE INTELLIGENC EMEPORTS ARE NOT SUFFICIENT. AND HILL NOT STAND UP TO STRICT RULES OF EVIDENCE. ONE POSSIBLE SOLUTION UNDER CONSIDERATION IS THE ESTABLISHMENT OF DETENTION CENTERS IN REMOTE PARTS OF THE COUNTRY WHERE THE REMAINING DETAINEES WOULD BE PERMITTED TO LEVE WITH THEIR FAMILES AND WORK. THESE WOULD NOT BE CONCENTRATION CAMPS, BUT PAROLE CENTERS WHERE ACTIVITIES OF THE INDIVIDUALS WOULD BE CLOSELY MONITORED. PRESUMABLY, THOSE WHO BEHAVE THEMSELVES EVENTUALLY WOULD BE FREED COMPLETELY OR PXMMMERMITTED TO LEAVE THE COUNTRY.

IT'S ALMOST COMMON KNOWLEDGE WITHIN THE ARMED FORCES AND POLICE THAT SOME OFFICERS WHO ARE VERY PROPER AND DISCIPLINED DURING DUTY HOURS WILL "GO AFTER" TERRORISTS ON THEIR OWN TIME USING INFORMATION GAINED DURING THEIR OFFICIAL ACTIVITIES, SOURCE HENT ON TO STATE THAT THE ORDER HAS GONE OUT THAT ALL SUCH ACTIVITIES MUST CEASE, HOWEVER, AS IN ANY COUNTERSUBVERSION CAMPAIGN, CERTAIN PEROPLE BECOME ACCUSTOMED TO OPERATING IN A LAWLESS ENVIRONMENT AND TO THE LUXURY OF LIVING OFF THE LOOT OBTAINED DURING THEIR OPERATIONS. SOURCE CONCLUDED THAT IT IS A SAD SITUATION, BUT THE FEW WHO PERSIST IN THEIR INDEPENDENT ANTI-TERRORIST CAMPAIGN, MANY PICTURING THEMSELVES AS TRUE PATRILOTS, WILL BE DEALT WITH SEVERELY. SOURCE DOES NOT EXPECT TO SEE THEM BROUGHT TO TRIAL. RAUTHER, HE EXPECTS THAT SOMEDAY THEY SIMPLY WILL APPEAR AS "CASUALTIES" IN AN OPERATION AGAINST SUBVERSIVE ELEMENTS.
