COMMENT (C) MG DIAZ BESSONES PURPOSE FOR MEETING

WAS TO DISCUSS HIS POLITICAL FUTURE, NO HUMAN RIGHTS THAT PART OF THE DISCUSSION WILL BE DISCUSSED IN A SEPARATE IR. THE FORMER PLANNING MINISTER WAS NOT PREPARED FOR SUCH AN ON SLAUGHT ON HUMAN RIGHTS AND HAD DIFFICULTY ANSWERING PENETRATING QUESTIONS. HIS CONFIDENCE WAS FURTHER SHAKEN WHEN HIS OWN UNDERSECRETARY (AND LONG TIME FRIEND) ATTACKED THE VIDELA GOVERN MENTS INTERNATIONAL CREDIBILITY. THERE IS LITT DOUBT THAT DIAZ BESSONE GOT THE MESSAGE, WHETHER HE STILL HAS ENOUGH INFLU ENCE TO DO SOMETHING ABOUT IT, OR WHETHER HE EVEN WANTS TO DO ANYTHING, REMAINS TO BE SEEN. HE CLAIMS THAT HI IS STILL ON GOOD TERMS WITH PRESIDENT VIDELA AND OTHERS IN THE GOVERNMENT. IF THIS IS TRUE, PERHAPS THE PRESIDENT WILL HEAR ONCE AGAIN THAT HUMAN RIGHTS ABUSES ARE INJURING THE ARGENTINE IMAGE ABRADD. EVEN THOUGH THE HUMAN RIGHTS DISCUSSION APPEARED TO BE CONFRONTATIONAL IN NATURE, IT WAS NOT. THE GENERAL WAS CONGENIAL AND FRANK AS HE HAS ALWAYS BEEN IN MEETINGS
