SUMMARY: (U) This report forwards an Amemb cable which addresses the Argentine disappeared issue.

ORIG COMMENTS: A. (6) One of the first ingredients needed for a return to a civilian government in Argentina is a guarantee for the military that they will not, at a later date and under a civilian government, be prosecuted for abuses which took place during the dirty war against subversive elements.

B. -(3) This guarantee has been called by some military as the Ley de Olvida (The law to Forget). This report tends to indicate that at least one political party now acknowledges the fact that they have to cooperate if they want to get back into the power circle. It is essential that the military be negotiating from a position of strength when they return the power (to make the Ley de Olvida work ). In this formula an improved economic situation and a reduction in inflation appear essential.

C. (2) This report is also of interest in its analysis that the majority of the population does not show much interest in the disappeared issue. This is backed up by RO's personal experience. Most Argentines acknowledge that abuses take place in war. The Argentine approach to the disappeared issue is in keeping with the way the Argentine population views most social issues. If it doesn't affect you directly keep your nose out of it.

1. \_(U) OVER THE PAST SEVERAL WEEKS RICARDO BALBIN, LEADER OF THE RADICAL PARTY, HAS ON THREE OCCASIONS PUBLICLY ADDRESSED THE ISSUE OF THE ARGENTINE DISAPPEARED. ON EACH HE HAS DELIVERED THE SAME HARSH MESSAGE: "THEY ARE NOT

SING, THEY ARE DEAD." THIS MESSAGE HAS BEEN ACCOMPANIED WITH RECOMMENDATIONS BY BALBIN THAT THE FAMILIES OF THE DISAPPEARED CEASE LOOKING FOR THE LOVED ONES AND BEGIN TO ACCEPT WHAT "EVERY ARGENTINE KNOWS," THAT THEY ARE NOT COMING HOME. BALBIN STATED TOO THAT THE "MISSING PERSONS CASE IS CLOSED" AND HIS CONCERN TODAY IS "ALLEVIATING THE PAIN AND PREVENTING ANOTHER GENERATION FROM SUFFERING."
