THAT A THREE MAN CELL HAD BEEN CAUGHT IN SAN MARTIN  
DE LOS ANDES (b)(3):10 USC 424 THE CELL WHICH WAS  
IDENTIFIED AS LEFTIST-TERRORIST BUT PROBABLY NOT  
MONTONERO HAD USED A TRANSMITTER TO INTERRUPT TRANS-  
MISSION OF MUNDIAL GAMES AND INTERJECT AUDIO MESSAGES  
FROM TERRORISTS AGAINST GOA. SOURCE INDICATED THAT  
THREE MAN GROUP IS BEING HELD AT A MILITARY UNIT,  
IN NEUQUEN AND IS PROVIDING VALUABLE INFORMATION.  
SOURCE INDICATED THAT THE CELL WAS APPREHENDED  
WITH THE AID OF ELEMENTS OF TH 601ST COMMUNICATIONS  
GROUP, LOCAL POLICE AND GENDARMERIA.

COMMENT: (S) PREVIOUS REPORT (b)(3):10 USC 424 HAD  
INDICATED FORMATION OF ELECTRONIC OPERATIONS  
COMPANIES, AND APPARENTLY THESE UNITS HAVE BEEN  
DISPERSED THROUGHOUT THE COUNTRY DURING MUNDIAL.  
THIS REPORT WOULD INDICATE AN RDF CAPABILITY IN THE  
FIELD, AND IS THE SECOND INDICATOR THAT TERRORIST  
ELEMENTS HAVE BEEN CAUGHT AFTER TRANSMITTING DIS-  
RUPTIVE MESSAGES.
