16. SUMMARY:

(U) This IR forwards a press report concerning the arrest and sentencing of 20 Montonero terrorists.

DETAILS: (U) The 20 terrorists received prison sentences ranging from one to nine years for violating national security laws, and specifically, committing acts promoting subversion and issuing terrorist propaganda. In addition, two persons allegedly involved with the terrorists were released for lack of evidence.

COMMENT: ~~(C)~~ It should be noted that the judge presiding over the sentencing was a Federal judge.

Condenan a 20 terroristas

Veinte extremistas de la organización subversiva montoneros fueron condenados a penas que oscilan entre un año y nueve de prisión, por fallo del juez federal de San Luis, doctor Eduardo Francisco Allende, en causa vinculada con la seguridad del Estado.

En las considerandos de la sentencia que precedieron —unas veinte

fejas— se establece que los condenados pertenecían a la mencionada organización, cumpliendo en ella distintas funciones, de de la promoción subversiva mediante "pintadas" hasta la participación en hechos de terrorista.

Por el "principio de la duda" que favorece al imputado, el juez dispuso la absolución de dos personas que prima facie aparecen como relacionados con las actuaciones, aunque sin elementos de juicio que probaran indudablemente su culpabilidad en hechos delictivos.

Los condenados son: José Meriberto Díaz a 9

años; Gilberto Amado Sosa Radi, 8; Aníbal Franklin Olivera, 9; José Fernando Vergés, 9; Néstor Ignacio Chacón, 5; Carlos Enrique Correcq, 8; Rubén Ismael Abdo, 5; Carlos Alberto Ramírez, 5; Raúl Alfredo Miranda, 3; Manuel Armando Alfonso, 8; Humberto Priamo Orozco, 3; Rubén Horacio Vera, 4; Teresa Lucy Cavallotti de Salinas, 4; Graciela Estela Babacasa, 4; Lydia Rosa Ordóñez, 4; Eva Gladys Orillano, 7; Eduardo Federico Liosa, 8; José Alfredo Ordóñez, un año y seis meses; Nora Isidra Fernández Aguilar, un año, y Gustavo Enrique Chacón, 4 años.
