1. This report gives a summary report of political violence and terrorist activities that have been reported to us by security forces during the month of November 1978.

2. November 9 - At 09:20 at Monroe 2532, 8th floor, Apt. A, Buenos Aires, the residence of Mr. Jorge Ricardo Romaniuk, employed as an engineer for the San Martin Plant of General Motors Argentina, an explosive device detonated, causing damage to apartments A, B, C, D and E and completely destroyed all doors on the 6th and 7th floors of the apartment building. There were no injuries.

explosive brigade personnel at the residence of Mr. Cussi Eduardo ~~XXXXX~~, Director General of General Motors of Argentina. The bomb consisted of a small electronic device (the device itself was not too powerful). There were no injuries.

- A package containing an explosive device was found in a vehicle parked in a car agency called "Automotores Pistini y CIA" Located at Avda. 649 Colon in Cordoba. The device was discovered by a mechanic of the agency who was checking the car. Explosive brigade personnel were summoned and removed the device and exploded it in front of the agency. Explosive personnel stated the device seemed to have been placed in the vehicle for some time and in a very discreet manner in order that the owner of the vehicle would not detect the bomb.

3. November 22 - At 1929 Salta, Buenos Aires, at a computer center/logistics office of the Argentine railroads, an explosive device was detonated, causing damage to walls, doors and windows. Neighboring buildings were also damaged. There were no injuries.

4. November 28 - At 21:40 there was an "audio" interference with Channel 13 TV transmitting the "Libertadores de America" soccer games between Boca Juniors and Deportivo Cali. The interference was heard in the areas of Street

41, 26 and 51, and the corners of ~~xxxx~~ 29 and 30  
(Italian Hospital and Humberto 1). To date authorities  
have been unable to determine if the interference was  
heard in other areas.

5. November 30 - At 16:15 during a joint operation, ~~by~~ the  
Sub-Zone combined forces and the Federal Police arrested  
an unidentified male terrorist in a residence located  
at Almirante Solier No. 6171, Wilde; Province of Buenos  
Aires.

- At 20:00 during an operation of the Special Task  
Forces of the Sub-Zone, Federal Capital, a male terrorist  
was killed during a confrontation.

- At 03:00 during an operation of the Federal Police  
forces combined with the Superintendency of Federal  
Security, a male terrorist was found in a residence  
located at 3771, 3 de Febrero, Remedios de Escalada,  
Province of Buenos Aires. The terrorist was arrested.

- At 04:20 an explosive device consisting of 1/2  
kilo of Trotyl exploded. The bomb completely destroyed  
a vehicle belonging to Mr. Raul Ferrari residing at  
262 Dorrego, Province of Rosario. Mr. Ferrari is self  
employed in designing and manufacturing plastic speed  
boats. The event, according to intelligence sources,  
was not related to any terrorist organization. There  
were no injuries.
