(U) ON 5 OCT 95, THE ARGENTINE ARMY CHIEF OF STAFF, GENERAL MARTIN ANTONIO ((BALZA)) PRESENTED A SPEECH ON "LEADERSHIP IN THE ARGENTINE ARMY" TO A

STAFF, GENERAL **MARTIN ANTONIO** ((**BALZA**)) PRESENTED A SPEECH ON "LEADERSHIP IN THE ARGENTINE ARMY" TO A LEADERSHIP SEMINAR BEING CONDUCTED AT THE COMMAND AND GENERAL STAFF COLLEGE OR ESG ("ESCUELA SUPERIOR DE GUERRA"). DURING THE DISCUSSION, GENERAL BALZA BEGAN OUTLINING HIS (AND PRESUMABLY THE ARGENTINE ARMY'S) VIEWS ON MORAL VERSUS IMMORAL ORDERS. HE USED THE EXAMPLE OF SPAIN, WHERE HE INDICATED THAT SPANISH SOLDIERS WERE PROHIBITED BY REGULATION FROM OBEYING THE IMMORAL ORDERS OF A SUPERIOR.

2. (U) GENERAL BALZA THEN WENT ON TO INDICATE THAT ALTHOUGH THE ARGENTINE ARMY DID NOT HAVE REGULATIONS PROHIBITING SUBORDINATES FROM OBEYING IMMORAL ORDERS PER SE, THE ARMY DID HAVE A DE FACTO PROHIBITION. GENERAL BALZA MADE NO ATTEMPT TO DEFINE AN IMMORAL ORDER NOR DID HE ACCEPT QUESTIONS CONCERNING THE ISSUE. HE ALSO MADE NO DISTINCTION BETWEEN IMMORAL VERSUS ILLEGAL ORDERS.
