- 2. (C) MG CANDIDO ((DIAZ)) ASKED THE ARGARM TO CONTINUE WITH THE ACCOMPLISHMENT OF THEIR MISSION IN FACE OF THE BUDGET CONSTRAINTS AND TERRIBLE SALARIES. HE PROMISED THE MEMBERS OF THE ARGARM THAT THEIR SACRIFICES TODAY WOULD INSURE A BETTER EQUIPPED AND BETTER PAID ARGARM IN THE FUTURE. THEN HE PROMISED THAT AS THE NEW CHIEF OF THE JOINT GENERAL STAFF, HE WOULD CARRY ON THE MISSION OF FURTHERING THE MEANING OF "JOINT" WHEN IT CAME TO INTEGRATING THE ARMED FORCES, EVEN IF THIS EFFORT RAN COUNTER TO THE INTERESTS OF SOME OF THE INDIVIDUAL SERVICES.
- 3. (C) MG ((GOMEZ SABAINI)), ON THE OTHER HAND, STARTED HIS SPEECH BY PROMISING THE ARGARM THAT HE WOULD CONTINUE THE JOB OF RESTRUCTURING AND DOWNSIZING THE ARGARM. HE THEN STATED THAT THE ARGARM OWES THIS RESTRUCTURING AND MODERNIZING TO THE ARGENTINE CITIZENS WHO ARE THE ONES THAT PAY TO MAINTAIN THE ARMED FORCES, AND DESERVE THE BEST POSSIBLE ARMY THEIR MONEY CAN BUY.
