~~(C/NF)~~ THIS REPORT REPRESENTS A WEEKLY SUMMARY. IT REVIEWS SIGNIFICANT TRENDS AND DEVELOPMENTS IN THE LIBERIA CRISIS BETWEEN 23 JUNE AND 29 JUNE.

1. (U) SUMMARY.

~~(C/NF)~~ FOLLOWING SEVERAL DAYS OF SPORADIC SKIRMISHES, FIGHTING ESCALATED ON THE 29TH. GUNFIRE WAS REPORTED IN SEVERAL AREAS OUTSIDE MONROVIA. THE NATIONAL PARTIOTIC FRONT OF LIBERIA

(NPFL) REOCCUPIED ROBERTS INTERNATIONAL AIRPORT (RIA) [REDACTED] ON THE 29TH. DISCIPLINE AMONG ARMED FORCES OF LIBERIA (AFL) TROOPS CONTINUES TO DETERIORATE. THE CAPITAL IS WITHOUT WATER FOR THE SECOND DAY. PEOPLE ARE BECOMING INCREASINGLY OUTSPOKEN IN THEIR DISSATISFACTION WITH PRESIDENT DOE'S

~~(C/NF)~~ THE LIBERIAN INDEPENDENT PRESS IS BECOMING INCREASINGLY ANTI-DOE AND ANTI-AFL. SEVERAL OPPOSITION PARTIES

THOUSAND PEOPLE PARTICIPATED IN A PEACE MARCH SPONSORED BY THE

BUNDU LEFT TOWN ON THE 27TH, AFTER SHOOTING ERUPTED IN THE STREETS OF MONROVIA. HIS ABRUPT DEPARTURE FORCED THE CANCELLATION OF PLANNED MEETINGS WITH OTHER POLITICIANS.

6. (U) COMMENT.

~~(C/NF)~~ THE DETERIORATING LIVING CONDITIONS IN THE CAPITAL COULD FUEL PUBLIC DEMANDS FOR DOE'S RESIGNATION. RECENT MILITARY DEFEATS, ESPECIALLY THE LOSS OF RIA, WILL FURTHER UNDERMINE THE ALREADY LOW AFL MORALE. THE TRANSFER TO ZWEDRU OF COL MOSES WRIGHT, ONE OF THE PRESIDENT'S CLOSEST CONFIDANTS AND ADVISERS, COULD INDICATE THAT DOE IS CONSIDERING AN ESCAPE TO GRAND GEDEH COUNTY.
