- 16. SUMMARY: (U) THE ARGENTINE PRESS HAS CHARGED, IN A STRONGLY CRITICAL ARTICLE, THAT CHILE IS CONDUCTING A PSYCHOLOGICAL OPERATIONS CAMPAIGN AGAINST ARGENTINA, THROUGH ITS NATIONAL MEDIA.
- 22. (U) DETAILS FOLLOWING IS A TRANSLATION OF THE 798185
 "LA OPINION" TEXT: "THE CHILEAN PRESS CORPS IN GENERAL, AND
 "EL MERCURIO" IN PARTICULAR, IS WAGING A PSYCHOLOGICAL CAMPAIGN ASMED AT ERDDING AND PRAGMENTING THE INTERNAL ARGENTINE
 PRONT, THE MORNING SANTIASO NEWSPAPER RECENTLY RELEASED
 THIS VENOMOUS ITEMS IT SEEMS THAT IN SOUTHERN ARGENTINA, THE
 CIVILIAN PORULATION IS "DEMORALIZEE", AND IS DISPLAYING A
 "CERTAIN MALASSE" DUE TO THE PRESENCE OF MILITARY FORCES IN
 THAT REGION, THIS IS A PSYCHOLOGOCIAL CAMPAIGN LACKING IN
 SUBSTANCE, IT REVEALS A LACK OF IMAGINATION, IT ALSO REVEALS
 THE UNPLEASANT SOURCE OF THE CAMPAIGN, SUT WE WILL NOT PURSUE
 THAT FURTHER.
- 2. (U) THE ARGENTINE CIVILIAN KNOWS PERFECTLY WELL WHY TROOPS ARE IN THE SOUTH: FOR THE DEFENSE OF NATIONAL SOVEREIGNTY, WHICH, IN THIS CASE, MEANS NOT PERMITTING INFRINGEMENTS ON TERRITORIAL INTEGRITY. THIS SAME TERRITORIAL INTEGRITY IS THREATENED BY EXPANSIONISM ON THE PART OF THE COUNTRY IN WHICH THE DAILY "EL MERCURIO" IS PUSLISHED. THAT IS, CHILE. A FEW DAYS AGD, THE CHILEAN CHANCELLOR (WHO, IF INDEED HE WORKED FOR THE CIA AS REPORTED IN THE US PRESS RECENTLY, SHOULD KNOW ALL ABOUT PSY DPS) ASSERTED THAT THE ARGENTINE PRESS WAS BEHAVING 'HYSTERICALLY.' WE WOULD LIKE TO KNOW HIS REACTIONS TO SOME OF THE FANTASTIC ITEMS WHICH APPEAR IN THE CHILEAN PRESS, AND WHICH ARE BROADCAST IN HIS COUNTRY.
- 3. (U) PSY OPS NEVER SURPASS ACTUAL EVENTS IN THEIR IMPACT. IN CERTAIN CASES==THIS NOT BEING ONE DF THEM==THEY DO SUCCEED IN FOMENTING SOME CONFUSION. SUT IN THE LONG RUN, REALITIES PREVAIL. A BASIC RULE FOR PSYOPS IS THAT THEY SHOULD BE PARTIALLY SASED ON FACT==AND NOT ON ILLUSION. FROM NORTH TO SOUTH, AS PROOF OF CIVILIAN MORALE WITH RESPECT TO THE

(U) "THESE EXAMPLES ARE BUT A FEW, BUT WHICH ARE THE BEST DEMONSTRATION OF THE STRONG WILL WHICH PREVAILS THROUGHOUT THE COUNTRY, AND WHICH SERVE TO PROVE AS ABSOLUTELY FALSE THE 'NEWS' WHICH IS PUBLISHED BY 'EL MERCURIO', AS WELL AS CALLING ATTENTION TO THE INCONSISTENCY OF THE ASSERTIONS MADE BY THE CHILEAN MEDIA.
- 5. (U) IN ANY CASE, 'EL HERCURIO' COULO BETTER OCCUPY ITSELF WITH COVERAGE OF REAL EVENTS, SUCH AS THE MATTER OF CHILEAN SPYING IN PERU. THE BOLIVIAN CLAIM TO ACCESS TO THE PACIFIC, OR THE ORIT BLOCKADE, WHICH, OF LATE, HAS FORCED CHILE TO LITERALLY BEAT ITS HEAD AGAINST A WALL." COMMENT: (C) A. (C) WHILE ARGENTINE PRESS COVERAGE OF THE BEAGLE CHANNEL DISPUTE IN THE PAST FOUR MONTHS HAS BEEN EXTENSIVE--PCLARINGFEATURES AT LEAST THREE FULL PAGES OF BEAGLE CHANNEL RELATED NEWS ON A DAILY BASIS; "LA OPINION", "LA PRENSA" AND "LA NACION" FEATURE BETWEEN FIVE AND TEN BEAGLE CHANNEL RELATED ARTICLE PER DAY--RO WOULD NOT CHARACTERIZE ITS REPORTING AS "HYSTERICAL," GIVEN THE NATURE OF THE DISPUTE, AND THE FACT THAT IT HAS GONE UNRESOLVED FOR OVER A CENTURY, HOWEVER, WITH THE EXCEPTION OF LA OPINION. WHICH FEATURE ANALYTICAL REPORTING, MUCH OF THE REPORTING IN THE ARGENTINE PRESS HAS CONSISTED OF THE PUBLICATION OF STATEMENTS MADE BY ARGENTINE GOVERNMENT LEADERS OR SPOKESMEN IN RESPONSE TO THE LATEST TURN OF EVENTS. THESE STATEMENTS ARE USUALLY HIGHLY EMOTIONAL IN TONE, AND ARE, FOR THE MOST PART, SHORT ON SUBSTANCE.

(C) PURSUANT TO THE USE OF THE MEDIA IN PSY OPS CAMPAIGNS IN ARGENTINA, A VIVIO EXAMPLE OF THIS IS THE GENEROUS ACCESSIBILITY GIVEN THE NATIONAL MEDIA WHEN THE ARMED SERVICES CONDUCT MILITARY EXERCISES, WHICH WERE WIDELY PUBLICIZED IN THE PROVINCIAL PRESS, AND COVERED BRIEFLY IN BUENOS AIRES NEWPAPERS
