DETAILS: (U) TRANSLATION OF TEXT OF THE "LA OPINION" REPORT FOLLOWS: "BEGINNING ON 4 SEPTEMBER, ALL EDUCATIONAL INSTITUTIONS-- PRIMARY, SECONDARY AND COLLEGE--IN THE PROVINCE OF CHUBUT WILL INCORPORATE INTO THEIR CURRICULA A GOVERNMENT (PROVINCIAL) PROGRAM FOR TEACHING THE ORIGINS OF THE TERRITORIAL DISPUTES IN THE BEAGLE CHANNEL AREA. THE PLAN, ACCORDING TO THE SOUTHERN PROVINCIAL GOVERNMENT, WOULD STIMULATE INTEREST IN, AND PROMOTE KNOWLEDGE OF, THE CONTROVERSY TO STUDENTS, FOR PURPOSES OF SECURING NATIONAL CONSCIOUSNESS FOR THE DEFENSE OF THE SOVEREIGNTY AND SECURITY OF BORDER AREAS. IT WAS ADDED THAT THE PATIENCE WITH WHICH OUR COUNTRY HAS TREATED MATTERS OF THIS SORT IN THE PAST SHOULD NOT BE INTERPRETED AS WEAKNESS, NOR AS AN INDICATION THAT WE WILL ACCEPT MUTILATIONS OF NATIONAL TERRITORIAL INTEGRITY."
