ACCORDING (b)(1);1.4 (c) (b)(1);1.4 (c) THE MEETING WILL RESULT IN THE SELECTION OF THE POPE TO MEDIATE THE DISPUTE AND THAT HE WILL "RUBBER STAMP" A CHILEAN PLAN WHICH WILL BE ACCEPTABLE TO ARGENTINA.

781288 OF THE SOCIOAD EDUCATIVA ACCION CIVICA (SEA) (SOCIETY FOR CIVIC ACTION EDUCATION). B. (b)(1);1.4 (c) STATED THAT CHILE WOULD AGREE TO A DIVISION OF THE ATLANTIC AND PACIFIC BETWEEN THE TWO COUNTRIES AND THAT THE 200-MILE OR 12-MILE RULE WOULD NOT APPLY.

C. (b)(1);Sec. 1.4(c) RELATED THAT CHILE WOULD ALSO AGREE TO THE MUTUAL EXPLORATION OF THE SEA SOUTH OF THE 3 CHANNEL ISLANDS AND THAT THESE THREE ISLANDS WOULD GO TO CHILE.

D. (b)(1);1.4 (c) THAT THE POPE WOULD BE CHOSEN AS THE MEDIATOR AND "RUBBER STAMP" THE CHILEAN PROPOSAL WHICH WOULD ALSO BE ACCEPTABLE TO ARGENTINA. (b)(1);Sec. 1.4(c) DID NOT SAY ANYTHING ABOUT A PIECE OF LAND TO THE SOUTH OF THE SEAGLE CHANNEL ISLANDS FOR ARGENTINA; THE EXACT LOCATION OF THE DIVIDING LINE BETWEEN THE TWO OCEANS WAS NOT DISCUSSED EITHER.

MEETING DID NOT SEE ANY COOPERATION COMING FROM CHILE AND VIEW A CONFLICT AS ALMOST INEVITABLE. THIS MSG COORD W/AMEMBASSY. DECL 11 DEC 1998.
