THE (b)(1);1.4 (c) WERE A CALCULATED PART OF THE GOA SCENARIO TO PREPARE FOR NEGOTIATIONS WHICH WOULD PERMIT ARGENTINA TO RECOUP SOME OF THE TERRITORY AND NATIONAL PRESTIGE THAT IT HAS LOST AS A RESULT OF THE BEAGLE CHANNEL ARBITRATION.

SIGNALS THAT (b)(1);1.4 (c) IS RECEIVING FROM THE GOA, (b)(1);1.4 (c) HAD SPECULATED THAT THE SIGNALS COULD BE GENERATED BY DISAGREEMENTS WITHIN THE JUNTA ON THE APPROPRIATE POLICY TO FOLLOW. THE INFORMATION THAT HAS BEEN PROVIDED (b)(1);1.4 (c) WOULD INDICATE THAT THERE IS AGREEMENT WITHIN THE JUNTA ON THE SCENARIO TO FOLLOW WITH RESPECT TO THE BEAGLE CHANNEL, AND THAT THE MIXED SIGNALS ARE A PURPOSEFUL PART OF THE SCENARIO. IF THAT IS THE CASE, THE PROPOSITION THAT THE MASSERA-VIDELA CONFLICT IS A SELF-GENERATED POLITICAL TACTIC OF THE JUNTA, AS (b)(3):10 USC 424 BECOMES MORE CREDIBLE, THERE ALSO EXISTS THE POSSIBILITY THAT THE CONVERSATION (b)(1);1.4 (c) ON THIS SUBJECT WAS (b)(1);1.4 (c) AND A PART OF A SCENARIO DEVELOPED TO COVER OVER SERIOUS DISAGREEMENTS WITHIN THE JUNTA ON THE PROPER COURSE OF ACTION TO TAKE WITH REFERENCE TO THE BEAGLE CHANNEL AREA. (b)(1);1.4 (c) FINDS IT DIFFICULT TO ACCEPT THE PROPOSITION THAT ALL THE DIFFICULTIES WITHIN THE JUNTA, THAT HAVE BEEN REPORTED BY SO MANY DIFFERENT (b)(1);1.4 (c) ARE FABRICATED. IT IS FEASIBLE THOUGH, THAT IN THE CASE OF THE BEAGLE CHANNEL DISPUTE THE DIFFERENCES BETWEEN THE APPROACHES OF MASSERA AND VIDELA ARE A CALCULATED PLAN WHICH THE ARGENTINE MILITARY PERCEIVE WILL STRENGTHEN THEIR POSITION. THIS COULD ALSO BE AN ATTEMPT TO RATIONALIZE BY POINTING TO WHAT THEY PERCEIVE AS A POSITIVE RESULT OF MIXED SIGNALS RESULTING FROM SERIOUS DIFFERENCES WHICH DO, IN FACT, EXIST WITHIN THE JUNTA.
