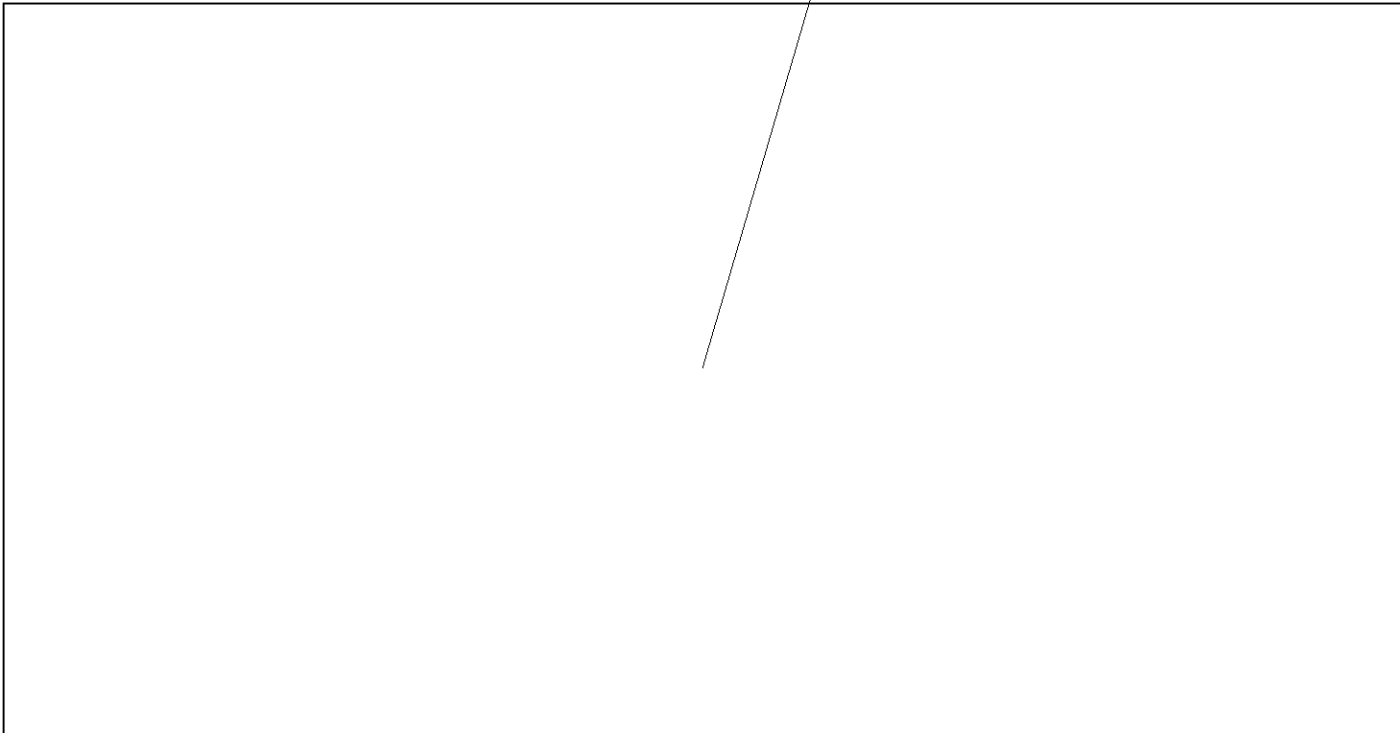

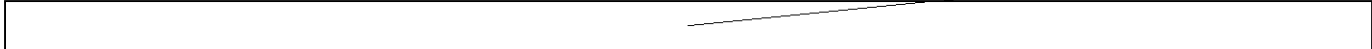

(FROLINA) SEES LITTLE HOPE FOR THE BURUNDI PEACE PROCESS.

DIPLOMAT ATTENDING THE ARUSHA ACCORDS ON 20011001. THE

2. (U) SALUTATION IS AS FOLLOWS, "EXCELLENCY, MR.
PRESIDENT, RE. REQUEST FOR POSTPONEMENT OF THE INSTALLATION
OF TRANSITIONAL GOVERNMENT SCHEDULED ON 1ST NOVEMBER 2001
DUE TO THE IMPOSSIBILITY OF FORMATION AND TRAINING OF
SPECIAL PROTECTION UNIT FOR THE INSTITUTIONS BEFORE ABOVE
MENTIONED DATE. EXCELLENCY MR. THE MEDIATOR."
3. (U) BEGIN TEXT -- SINCE 23RD JULY 2001 FOLLOWING THE
RESOLUTION OF THE 15TH SUMMIT OF HEADS OF STATE OF THE
REGION ON BURUNDI THAT THE 1ST NOVEMBER 2001 SHOULD BE
OFFICIAL START OF TRANSITIONAL GOVERNMENT, WE DO NOTICE
THAT THE PREREQUISITE CONDITION WHICH IS THE FORMATION AND
TRAINING OF SPECIAL PROTECTION UNIT FOR THE TRANSITIONAL
INSTITUTIONS IN ACCORDANCE WITH ITEM EIGHT (VIII) OF THE
CONDITIONS SIGNED BY MAJOR PIERRE ((BUYOYA)) ON 23RD JULY
2001.
4. (U) PARAGRAPH TWO READS - IN YOUR MESSAGE ADDRESSED TO
BURUNDI PEOPLE AFTER 15TH SUMMIT OF HEADS OF STATE OF THE
REGION ON BURUNDI, YOUR EXCELLENCY HAS RECOGNIZED ITS
IMPORTANCE IN THESE TERMS -- "UNFORTUNATELY, DUE TO
SECURITY REASONS, THIS PERIOD WON'T START IMMEDIATELY, BUT
ON FIRST NOVEMBER 2001, AND THIS FOR GOOD REASON. AS YOU
KNOW, MOST OF BURUNDI (SP-BURUNDI) POLITICAL LEADERS ARE IN
EXILE, THEY CANNOT RETURN IN BURUNDI UNLESS THEIR SECURITY
GUARANTEE IS ASSURED. UNFORTUNATELY, THESE LEADERS DO NOT
THINK THAT THE ACTUAL SECURITY ORGANS, BE IT THE BURUNDI

ARMY OR POLICE CAN GUARANTEE THIS SECURITY. FOR THIS REASON A NEUTRAL ORGAN IS NEEDED.

5. (U) PARAGRAPH THREE READS - THE INTERNATIONAL COMMUNITY AND THE REGION RECOGNIZE THE WELL FOUNDED OF THIS DEMAND. ALSO, DURING THEIR MEETING ON 23RD JULY 2001, POLITICAL LEADERS OF THE REGION HAVE DECIDED TO ESTABLISH A CREDIBLE SPECIAL PROTECTION UNIT SUFFICIENTLY IMPORTANT TO ASSURE THE REQUIRED PROTECTION.

6. (U) PARAGRAPH FOUR READS - THE DATE OF NOVEMBER 2001 HAS BEEN RETAINED BECAUSE THE ESTABLISHMENT OF SUCH A FORCE WILL TAKE A CERTAIN TIME . EVERYTHING WILL BE DONE IN ORDER TO IMPLEMENT IT WITHIN THE TIME LIMIT. POLITICAL LEADERS OF THE REGION HAVE ALSO DECIDED TO INVITE UNO AND INTERNATIONAL COMMUNITY TO SEND TROOPS IN BURUNDI IN ORDER TO REINFORCE SECURITY. THESE TROOPS WILL BE DEPLOYED IN BURUNDI TO ASSIST AND NOT AS FORCE FOR OCCUPYING. I INVITE BURUNDIANS TO RESERVE TO THEM A WARM WELCOME AND TO COOPERATE WITH THEM.

7. (U) PARAGRAPH FIVE READS - EXCELLENCY MR. THE MEDIATOR, FIFTY NINE DAYS AFTER, FROLINA AND PALIPEHUTU NOTICE WITH REGRET THAT SO FAR NO ACTION IS BEING UNDERTAKEN FOR THE RAPID FORMATION OF THIS UNIT IN ORDER TO CONFORM TO THE SCHEDULE OF ITS ESTABLISHMENT AS DETERMINED BY THE 4TH SESSION OF THE IMPLEMENTATION MONITORING COMMITTEE (IMC) HELD IN ARUSHA FROM 14TH TO 20TH AUGUST 2001.

8. (U) PARAGRAPH SIX READS - WE DO NOTICE ALSO THAT THE MIXT (SP-MIXED) COMMISSION CONSISTING OF THE REPRESENTATIVES OF ARMED PARTIES SIGNATORIES TO THE AGREEMENT (FROLINA, PALIPEHUTU, CNDD AND THE GOVERNMENT) HAS NOT YET B EEN ESTABLISHED SO AS TO TECHNICALLY STUDY THE ESTABLISHMENT OF THIS UNIT, ESPECIALLY -- DESIGNATION OF RESPONSIBLE PERSON FOR THIS OPERATION, PLACE OF FORMATION AND LOGISTICS WHEREAS ONLY FORTY ONE DAYS REMAIN BEFORE 1ST NOVEMBER 2001. CONSEQUENTLY, THE DATE OF 1ST NOVEMBER 2001 SHOULD BE POSTPONED UNTIL DEPLOYMENT OF THIS SPECIAL PROTECTION UNIT FOR TRANSITIONAL INSTITUTIONS.

9. (U) PARAGRAPH SEVEN READS - EXCELLENCY, MR. THE MEDIATOR, THE MOST IMPORTANT AND URGENT FOR US IS NOT TO HAVE A NEW GOVERNMENT ON 1ST NOVEMBER 2001, BECAUSE PEOPLE OF BURUNDI HAS KNOWN SO MANY WHICH HAVE NEVER SPARED HIM THE MISFORTUNES THAT HE HAS BEEN FACING SINCE INDEPENDANCE (SP-INDEPENDENCE) TILL TO DATE. OUR FIRST CONCERN IS TO HAVE SUFFICIENT SECURITY FOR THE NATIONAL UNION GOVERNMENT IN ACCORDANCE WITH ARUSHA PEACE AND RECONCILIATION AGREEMENT FOR BURUNDI.

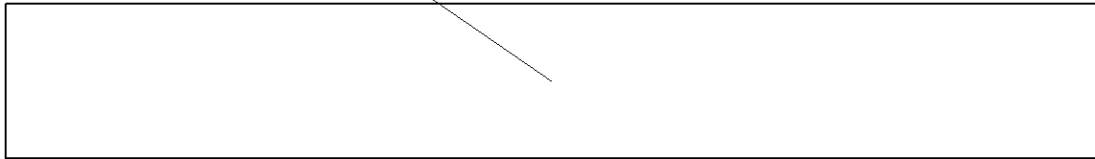

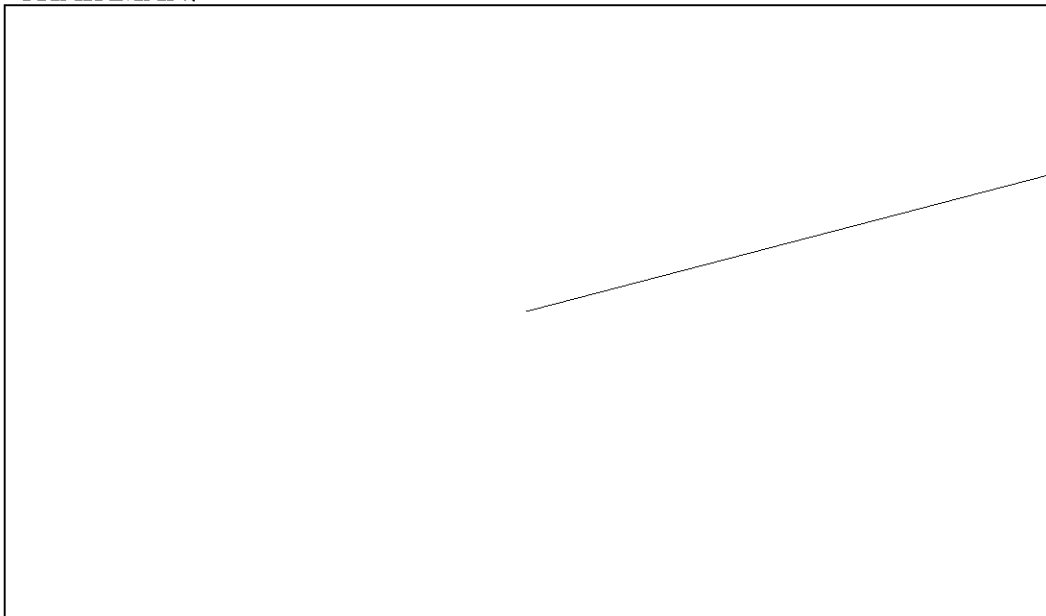
NIGHT OF 27-28 AUGUST 2000 AIM AT PROLONGING AND REINFORCING PARTNERSHIP GOVERNMENT IN DETRIMENT OF ARUSHA PEACE AND RECONCILIATION AGREEMENT FOR BURUNDI.

12. (U) PARAGRAPH TEN READS - IN ACCORDANCE WITH ARUSHA PEACE AND RECONCILIATION AGREEMENT FOR BURUNDI, ESPECIALLY IN ARTICLE EIGHT PROTOCOL FIVE -- IN ITEM EIGHT OF THE CONDITIONS SIGNED BY THE PRESIDENT PIERRE BUYOYA ON 23RD JULY 2001 -- THE JOINT COMMUNIQUE OF 15TH SUMMIT OF HEADS OF STATE OF THE REGION AND THE DECLARATION OF THE CHAIRMAN OF IMC DURING THE 4TH SESSION HELD IN ARUSHA ON 14TH - 20TH AUGUST 2001, THE COMBATANTS OF FROLINA AND PALIPEHUTU ARE IN THE STATE OF MAXIMUM ALERT TO TAKE PART IN THE FORMATION AND TRAINING OF SPECIAL PROTECTION UNITS FOR THE TRANSITIONAL INSTITUTIONS.

13. (U) PARAGRAPH ELEVEN READS - EXCELLENCY, MR. THE MEDIATOR, WE HAVE THE HONOUR (SPHONOR) TO TAKE THIS OPPORTUNITY TO EXHORT YOU TO DO EVERYTHING SO AS TO START WITH THE FORMATION AND TRAINING OF SPECIAL PROTECTION UNIT AND WE DO KINDLY REQUEST YOU TO EXERCISE YOUR POWER TO FIX ANOTHER DATE FOR THE INSTALLATION OF TRANSITIONAL GOVERNMENT IN TAKING INTO ACCOUNT NECESSARY TIME FOR THE FORMATION, TRAINING, AND DEPLOYMENT OF SPECIAL PROTECTION UNIT FOR THE INSTITUTIONS." END TEXT.

14. (U) THE CLOSING READS - PLEASE ACCEPT, YOUR EXCELLENCY MR. THE MEDIATOR, THE ASSURANCE OF OUR HIGHEST CONSIDERATION.
