MAULAWI SHARAFUDDIN HOLDS COURT ON EVERY FRIDAY STARTING AT APPROXIMATELY 1630 HOURS AT THE LOCAL MOSQUE. MAULAWI SHARAFUDDIN IS APPROXIMATELY 56 YEARS OF AGE, AVERAGE HEIGHT, HEAVY BUILD, TAN COMPLEXION. AND SALT-AND-PEPPER BEARD. HE IS TYPICALLY OBSERVED. WEARING A WHITE TURBAN.
