THE SHURA WAS ATTENDED BY GUL AGHA, WHO BROUGHT MESSAGES FROM **MULLAH OMAR**, WHO ESTABLISHED A NEW 10-MEMBER COUNCIL TO ACT AS A CONSULATE AND TO CONSIDER ANY MESSAGES HE PASSES TO THE SHURA.

2. ~~(S)~~ (b)(3):10 USC 424 IN LATE SEPTEMBER 2010, THE TALIBAN **QUETTA SHURA** WAS HELD. THE SHURA WAS ATTENDED BY GUL ((AGHA)), WHO BROUGHT MESSAGES FROM **MULLAH ((OMAR))**. ALSO IN ATTENDANCE WERE HAJI MULLAH MOHAMMED ((RAHIM)), THE TALIBAN GOVERNOR IN HELMAND PROVINCE, AFGHANISTAN; MOHIBULLAH ((AKHUNDZADA)), THE CURRENT TALIBAN GOVERNOR OF KANDAHAR PROVINCE, AFGHANISTAN; MULLAH ABDUL ((QAHEER)), THE TALIBAN GOVERNOR OF URUZGAN PROVINCE, AFGHANISTAN; MULLAH ((RAZAQ)), THE TALIBAN GOVERNOR OF ZABUL PROVINCE, AFGHANISTAN; AND MULLAH ((NAQIBULLAH)), THE TALIBAN COMMANDER FROM THE KHAKREZ DISTRICT, KANDAHAR PROVINCE, AFGHANISTAN.
