ONE OF THE TANKS SUFFERED RECURRING CLUTCH FAILURES WHICH HAVE SENT NORINCO BACK TO THE DRAWING BOARD TO TRY TO DESIGN A MORE RUGGED TANK FOR THE RIGOROUS TESTING IN IRAN. AS (b)(1),1.4 (c) SAID, YOU CAN MARK THIS ONE AS A LOSS ON THE ARMS SALE "WORLD CUP" TALLY.

3. (S/NF/NC) NORINCO WILL CONTINUE TO COMPETE FOR THE CONTRACT BUT DOES NOT EXPECT TO HAVE A TANK READY FOR AT LEAST SIX MONTHS.
