LARGE (NFI) ARE VERY UPSET WITH UNITED STATES INVOLVEMENT AND WILL RETALIATE. AT A MINIMUM, HARASSMENT AGAINST AMEMBASSY, JUSMAG, CLARK AFB AND AFP (ARMED FORCES OF THE PHILIPPINES) PERSONNEL WILL TAKE PLACE. THE FINAL DECISION ON HOW SEVERE THE ACTION WILL BE DEPENDS UPON THE OUTCOME OF THE TRIAL OF THE CAPTURED REBEL LEADERS. IF THE PUNISHMENTS ARE STRICT OR SEVERE, THEY (COUP

PLANNERS) ARE PREPARED TO KIDNAP (FOR SWAP) OR KILL (FOR EXAMPLE) THE ABOVE MENTIONED. (b)(1);Sec.14(c) TEAMS ARE ALREADY ORGANIZED TO CARRY OUT WHATEVER ACTION IS NECESSARY (b)(1);Sec.14(c) THE THREAT IS REAL AND THAT THE COUP PERSONNEL HAVE GREAT ANGER TOWARD THE U.S.

HE SAID TURINGEN WAS INSTRUMENTAL IN PLANNING ALL MAJOR OPERATIONS, HELPING ACQUIRE SUPPLIES AND MONEY, AND MAKING CONTACTS IN THE AMERICAN COMMUNITY TO ESTABLISH THE U.S. MOOD IN REFERENCE TO A COUP. HE WILL ALSO BE A GREAT INFLUENCE IN DECIDING THE DEGREE OF RETALIATION TOWARD AMERICANS AND TARGET SELECTION. (b)(1);Sec.14(c) TURINGEN AND HIS CO-PLANNERS ARE STILL IN MANILA AT THREE DIFFERENT LOCATIONS: PASIG, MAKATI AND SAN JUAN. THEY HAVE REITERATED THAT THEY WILL NOT WAIT UNTIL THE 1992 ELECTION BECAUSE THE COUNTRY CAN'T WITHSTAND TWO MORE YEARS OF PRESIDENT ((AQUINO)). (b)(1);Sec.14(c) THE REBELS WERE ABLE TO MONITOR ALL U.S. EMBASSY RADIO NETS THROUGHOUT THE ATTEMPTED COUP. THE REBELS THEMSELVES WERE USING UHF AND VHF AIR BAND FRDM 100.00 TO 140.00 MHZ.

(b)(1);Sec.14(c) THESE ARE NOT IDLE THREATS, AND THE U.S. WILL SEE SOME TYPE OF REPERCUSSIONS FROM U.S. SUPPORT TO THE AQUINO GOVERNMENT. IT IS OBVIOUS THAT THE ATTEMPTED COUP WAS NOT ONLY ON A LARGER SCALE THAN THE 1987 ATTEMPT, BUT MUCH BETTER PLANNED AND ORCHESTRATED. THE REBELS SOMEHOW FELT THAT THE U.S. WOULD NOT GET INVOLVED IN THE COUP AND NOW FEEL BETRAYED BY THE U.S. ALTHOUGH THE ONLY SHORT TERM LEFTOVER ACTION OF THIS ATTEMPTED COUP IS THE THREAT
