DELIVERY OF THE FT-7'S HAS BEGUN IN RECENT WEEKS AND WILL BE ACCOMPLISHED BY IRANIAN AIR FORCE 747 AIRCRAFT IN GROUPS OF SIX AIRCRAFT AT A TIME.

[REDACTED] FURTHERMORE ON 901225, RO OBSERVED AN IRANIAN AIR FORCE BOEING 747 WITH REFUELING BOOM PARKED IN THE SAME AREA (RAMP IN FRONT OF OLD PASSENGER TERMINAL) AS THE MID-DECEMBER OBSERVATION. THE AIRCRAFT WAS CLEARLY MARKED WITH AN IRANIAN FLAG AND THE NUMBER 5-8103 ON THE TAIL, THE LETTERS EP-SHC ON THE UPPER FUSELAGE, AND THE LETTERS IRIAF ON THE NOSE. NO ACTIVITY WAS OBSERVED AROUND THE AIRCRAFT AT THE TIME OF [REDACTED] OBSERVATION (FROM APPROX 0300 TO 0530Z).
