SUBJ: DIA [REDACTED] ANALYTICAL PRODUCT - (U) AFGHANISTAN: TALIBAN
CLAIM ATTEMPTED ASSASSINATION OF U.S. VICE PRESIDENT

(S) AT APPROXIMATELY 0540Z ON 27 FEBRUARY, A SINGLE SUICIDE BOMBER WEARING A VEST DETONATED HIMSELF OUTSIDE THE FRONT GATE OF BAGRAM AIRFIELD, KILLING BETWEEN 13 AND 18 INDIVIDUALS, INCLUDING ONE U.S. SOLDIER AND ONE U.S. GOVERNMENT CONTRACTOR. AFTER THE BOMBING, A TALIBAN SPOKESPERSON CONTACTED THE PRESS AND CLAIMED RESPONSIBILITY FOR THE ATTACK, STATING IT HAD TARGETED THE U.S. VICE PRESIDENT, WHO HAD STAYED OVERNIGHT AT THE AIRBASE. THE ATTACK WAS NOT LIKELY INTENDED TO BE A REALISTIC ASSASSINATION ATTEMPT, BUT WAS LIKELY TIMED TO COINCIDE WITH THE VICE PRESIDENT'S VISIT IN ORDER TO GENERATE PUBLICITY AND THE PERCEPTION OF A SUCCESSFUL OPERATION AGAINST A SENIOR U.S. GOVERNMENT OFFICIAL.

AL-QAIDA WILL SEEK TO PROMOTE THE ATTACK AS AN EXAMPLE THAT THE INSURGENCY IS ENTRENCHED AND SUCCEEDING INSIDE AFGHANISTAN. IN ADDITION, AL-QAIDA WILL LIKELY PORTRAY SUCH ATTACKS AS THE DUTY OF LOCAL AFGHANS IN THE GLOBAL JIHAD.
