SUMMARY: (S/NF/NN) BETWEEN 1980-87, CHINA DELIVERED 4.8 BILLION USD WORTH OF ARMS TO IRAN, INCLUDING AIRCRAFT, MISSILES, TANKS, AND ARTILLERY, USING PAKISTAN, BRAZIL, AND BOLIVIA AS INTERMEDIARIES. IRANIAN PILOTS ARE BEING TRAINED IN CHINA AND NORTH KOREA.

TEXT: 1. (S/NF/NN) (b)(1),1.4 (c) WHO RECEIVED THE INFORMATION FROM A VERY HIGH-LEVEL, NON-CHINESE, OFFICIAL IN BEIJING, CHINA DELIVERED TO IRAN 4.8 BILLION USD WORTH OF ARMS BETWEEN 1980 AND THE END OF 1987. THESE INCLUDED SILKWORM MISSILES/LAUNCHERS, F-6 AND F-7 FIGHTERS, T-59 TANKS, TYPE 63 APC'S, 107 MM MRL'S, ARTILLERY FIRE CONTROL SYSTEMS, HQ-2 SAM'S, SURFACE-TO-SURFACE TACTICAL MISSILES, AND 130 MM AND 122 MM FIELD ARTILLERY. THE ARMS HAVE BEEN DELIVERED DIRECTLY FROM CHINA, AS WELL AS BEING CONTRACTED/ROUTED THROUGH PAKISTAN, BRAZIL, AND BOLIVIA. IRAN IS TRAINING PILOTS IN CHINA AND NORTH KOREA, AND CHINESE SPECIALISTS ARE IN THREE IRANIAN CENTERS. (b)(1),1.4 (c) THAT THE INFORMATION CAME DIRECTLY FROM TEHRAN, NOT FROM CHINA, AND THAT IT IS HIGHLY RELIABLE. THE FOLLOWING PARAGRAPHS SPECIFY THE EXACT NUMBER AND TYPES OF EQUIPMENT DELIVERED.

(b)(1),1.4 (c) DOES NOT KNOW ANY ADDITIONAL INFORMATION ABOUT HOW THEY WERE DELIVERED, WHAT ROUTE, OR EXACT SCHEDULE; NOR DOES (b)(1),1.4 (c) KNOW IF THERE WILL BE ANY ADDITIONAL DELIVERIES.

4. (S/NF/NN) (b)(1),1.4 (c) THAT BETWEEN 1980 AND THE END OF 1987, CHINA DELIVERED 100 F-6'S TO IRAN. SOME OF THEM WENT THROUGH PAKISTAN AND SOME WENT DIRECTLY FROM CHINA VIA SHIP. IN ADDITION, IRAN HAS CONTRACTED FOR 120 F-7'S. BY THE END OF DEC 87, HOWEVER, ONLY 10

PILOTS ARE TRAINING IN WUHAN, CHINA, IN THE F-7, AND
60 PILOTS ARE TRAINING IN THE F-6 IN NORTH KOREA AT AN
UNIDENTIFIED LOCATION. (b)(1),1.4 (c) DOES NOT KNOW WHETHER
THE PILOTS ARE FROM THE AIR FORCE OR FROM THE REVOLUTION-
ARY GUARDS.

6. (S//NF//NN) OF THE 350 T-59 TANKS CHINA HAS DELIVERED,
200 ARRIVED BETWEEN 1980 AND THE END OF 1986. THE
REMAINING 150 WERE DELIVERED IN 1987, USING BOLIVIA
AS AN INTERMEDIARY. (b)(1),1.4 (c) DOES NOT KNOW EXACTLY HOW
THE TANKS SOLD THROUGH BOLIVIA WERE DELIVERED.

7. (S//NF//NN) (b)(1),1.4 (c) THE TOTAL
AMOUNT OF ARMS IRAN BOUGHT FROM CHINA BETWEEN 1980 AND
THE END OF 1987 WAS 4.8 BILLION USD. BASED ON CHINESE
INSISTENCE, THE ENTIRE SUM WAS PAID IN CASH. THERE WAS
NO CREDIT OR EXCHANGE FOR OTHER GOODS. (b)(1),1.4 (c) DOES NOT
KNOW WHETHER THE MONEY FOR THE REMAINING 110 F-7'S IS
INCLUDED IN THIS FIGURE OR NOT.
