2. (S) (b)(1),1.4 (c) THAT A GREAT DEAL OF MONEY WAS OWED TO CAAC BY THE IRAQI GOVERNMENT FOR TRANSPORTATION FEES. CAAC HAS RECEIVED NO PAYMENT FOR ITS SERVICES AND OFFICIALS OF THE COMPANY FEAR THAT THEY WILL NEVER RECEIVE PAYMENT.
