B. (U) EGYPT: ISLAMIC GROUP CLAIMS HURGHADA ATTACK. THE ISLAMIC GROUP (IG) CLAIMED RESPONSIBILITY FOR THE 27 SEPTEMBER TERRORIST ATTACK IN HURGHADA THAT KILLED THREE, INCLUDING A GERMAN TOURIST. THE 30 SEPTEMBER STATEMENT ALSO REPEATED A THREAT TO FOREIGN TOURISTS AND THE EGYPTIANS WHO DEAL WITH THEM. THE IG WARNED THE EGYPTIAN GOVERNMENT THAT THERE WOULD BE MORE ATTACKS IN OTHER PREVIOUSLY SAFE TOURIST DESTINATIONS. THE AUTHENTICITY OF THE STATEMENT HAS BEEN QUESTIONED DUE TO ITS CONTRASTS WITH PREVIOUS CLAIMS. THE TEXT REPORTEDLY WAS HANDWRITTEN, CONTAINED SEVERAL GRAMMATICAL MISTAKES. AND DID NOT INCLUDE AS MANY KORANIC VERSES.
