AND FREQUENT RESHUFFLING OF AGENCY, MILITARY, AND POLITICAL HEADS WILL UNDOUBTEDLY ADVERSELY IMPACT ANY EFFORT TO ACCOMPLISH THE GOALS IDENTIFIED IN THE RECENT MEETING. AT LOCAL LEVELS, ANY NEW ACTIONS, ESPECIALLY TRAVEL RESTRICTIONS, WILL PROBABLY BE VIEWED AS INCREASED SUPPRESSION OF BASIC HUMAN RIGHTS. FAZ UNITS, INCLUDING BORDER GUARDS AND CUSTOMS OFFICIALS, WHO ARE OFTEN UNPAID, WILL PROBABLY SEE THE NEW POLICIES AS A MEANS TO GARNER A BETTER SUBSISTENCE.
